2-The reason of conflict between two countries


The conflict between the two countries based on the sectanism.


Q7. The country is faced with unprecedented economic, political and constitutional crisis. Critically evaluate the statement and give recommendations.

## 4: Subsidies in wrong manner


Pakistan subsidize those that are not much productive or not giving
