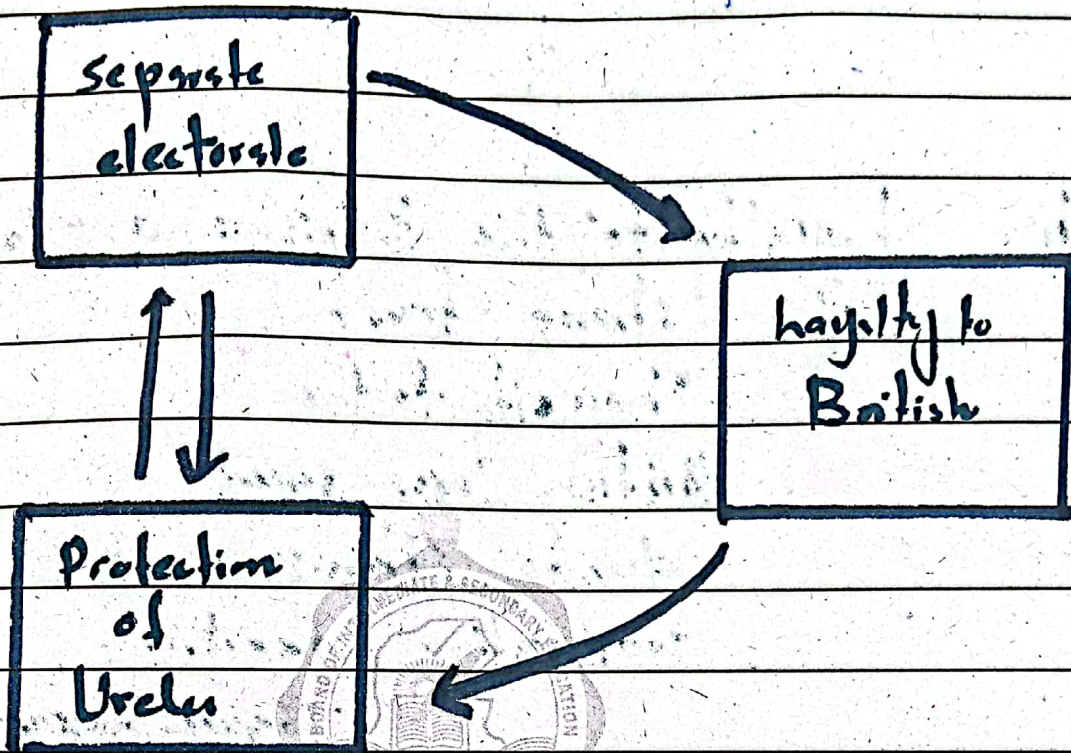
4. Objectives of Simla Deputation:

Further, Urdu protection was also demand of Muslims. In fact, Congress posed a threat to Urdu culture. Therefore, Muslims wanted to protect Urdu.

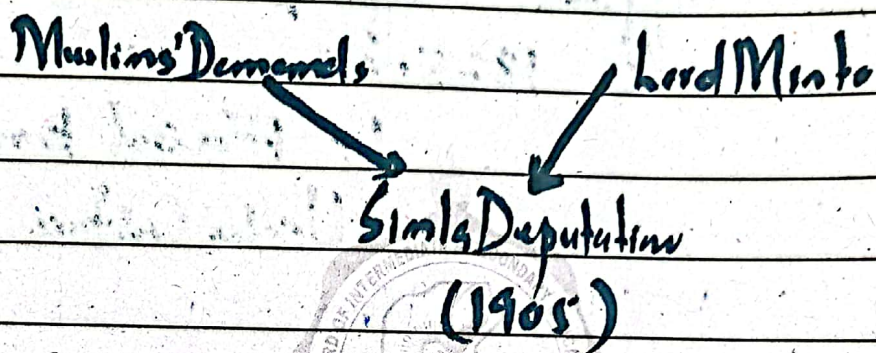
5. Response of Lord Minto with respect to Simla Deputation
