4. Responsibilities of juvenile justice system

Assist parents and society

protect child's rights

Assist juvenile in language

5- Role of juvenile justice system in prevention of juvenile crimes in Pakistan

JJS has played its

a) Imposing strict laws against using juvenile in crimes
