public welfare"

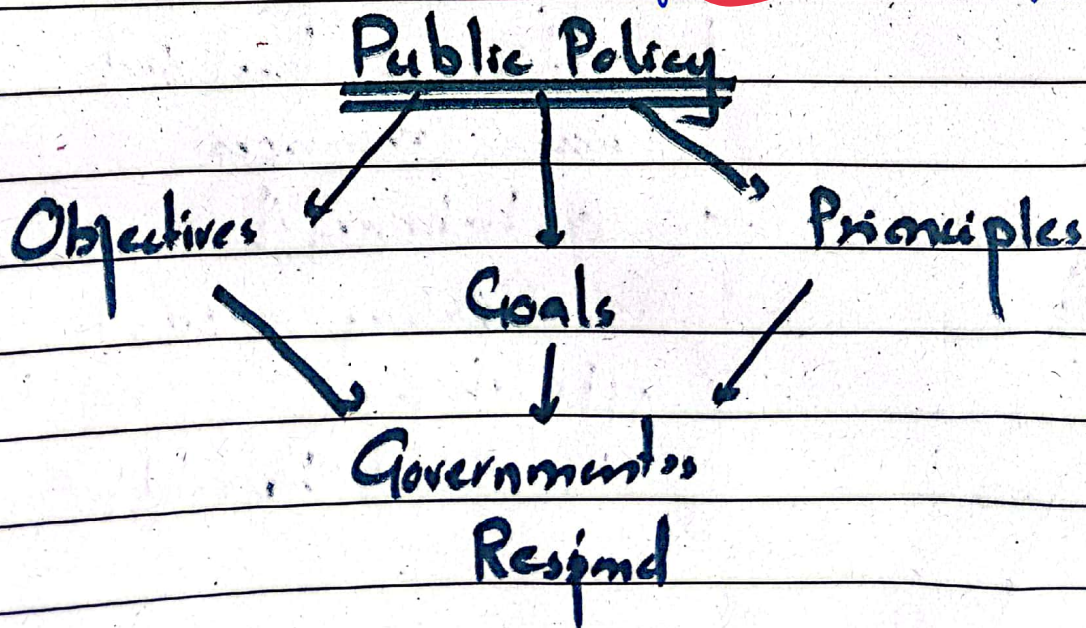

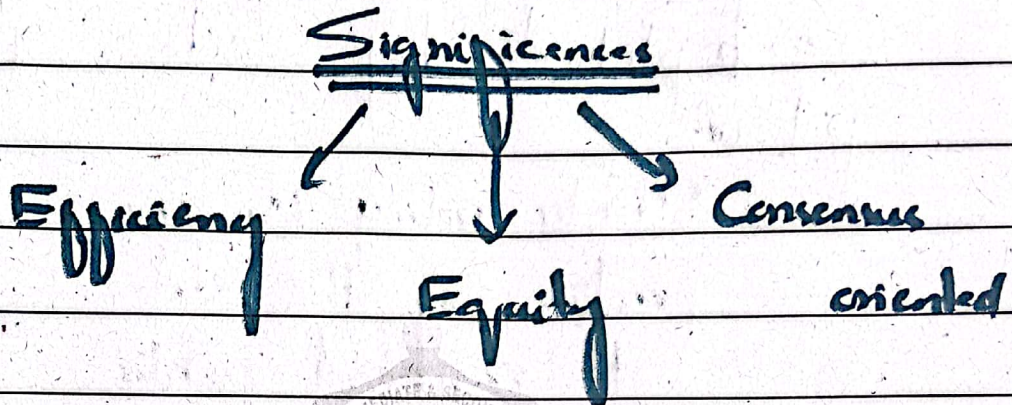
Therefore, public policy is a set of public necessities for their welfare

"Planning Commission is the highest authoritative body."



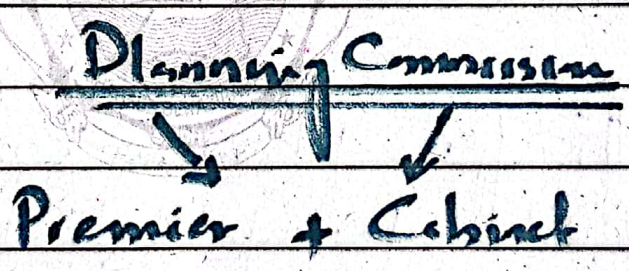
