What is meant by the term "Proxy War"? Are there any extrinsic factors at play in the internal security situation in Pakistan?

Proxy war ::

Tyron Glon defines Proxy war as "Directing a use of force by politically motivated actors to influence to Political situation of a target state."

The era of Cold war between the two superpowers of world from 1945 to 1989 saw the considerable rise in Proxy wars. For example the war in Vietnam and the biggest of all of that time was Pakistan. Pakistan served as a battle ground for US to counter the Soviet expansion in Afghanistan. It served as a proxy for US in a sense that Pakistan was provided with heavy military and economic aid to serve the US interest. Pakistan served the US interest to its fullest as a proxy and US managed to make Soviet Union surrender in the

very battleground of Afghanistan.

Proxy war is a war in which the Patron state invests heavily in the client state to achieve its interests in the target state. It can be done through hybrid warfare, cyber warfare i.e. the 5th generation warfare.

The Patron state goes to any extent if it has to achieve its ideologic image in the international community.

The fact that a proxy war is fought to avoid direct confrontation with the target state remains on the ground that the Patron state wants to avoid a Mutual Assured Destruction and without making a negative image, achieves its interests.

An example of such an event is Mutual Assured Destruction and its repercussions is evident in the

Case of Nuclear attack on Nagasaki and Hiroshima, the one and only example of nuclear warfare to that.

1. Cross border terrorism:

As Pakistan trained Mujahideen to take part in war in Afghanistan, with the end of war Pakistan's border became porous for cross border terrorism and it became the victim of the war itself. To control such activities from non-state actors such as TTP Pakistan must look for a way to secure its borders.

2. Refugee Crisis:

On the wake of war in Afghanistan, there had been an incredible refugee influx from

Afghanistan to Pakistan. Thus Paving the way for terrorist activities operating across the borders.

Non-state Actors:

One of the sole concerns for internal security matters of Pakistan is the question of non-state actors which are under safe heavens in Pakistan. Unless this concern is not addressed effectively Pak will continue to face terrorism in its soil.
