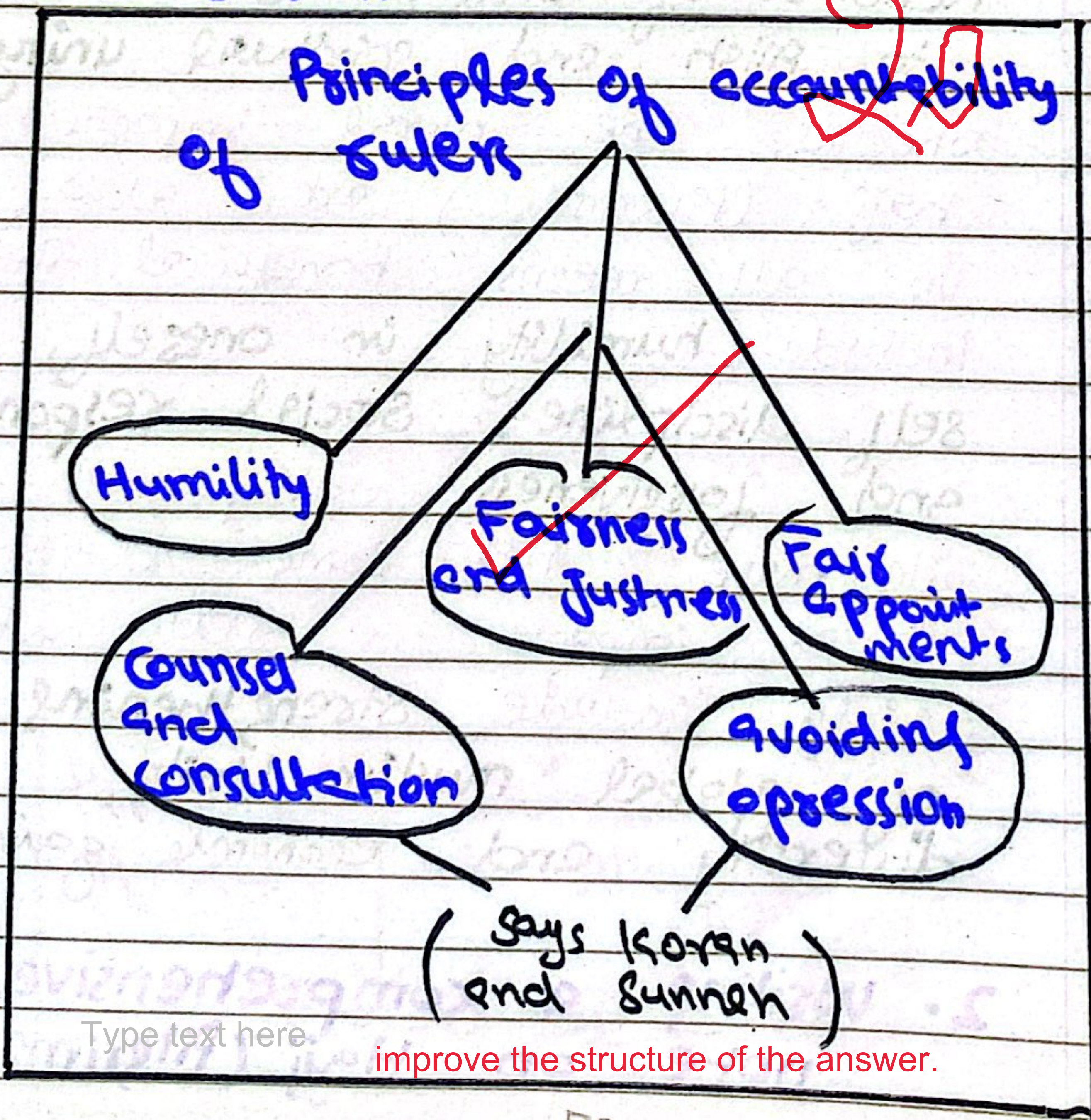
3-3, Humility

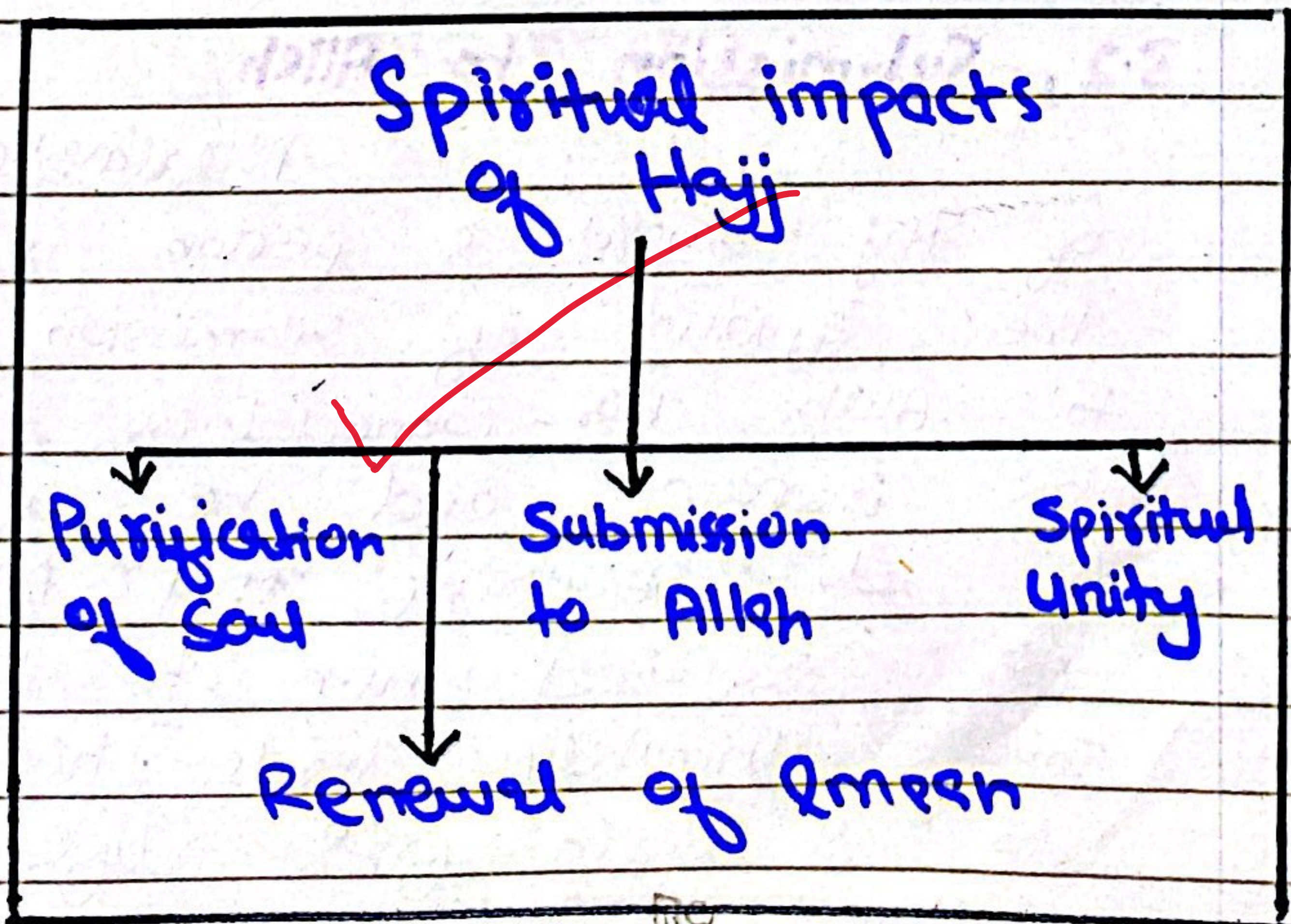
2. Writing a comprehensive note on Hajj (Pilgrimage)

Performance of Hajj bestowed Muslims with spiritual impacts. Following are some important ones in this regard

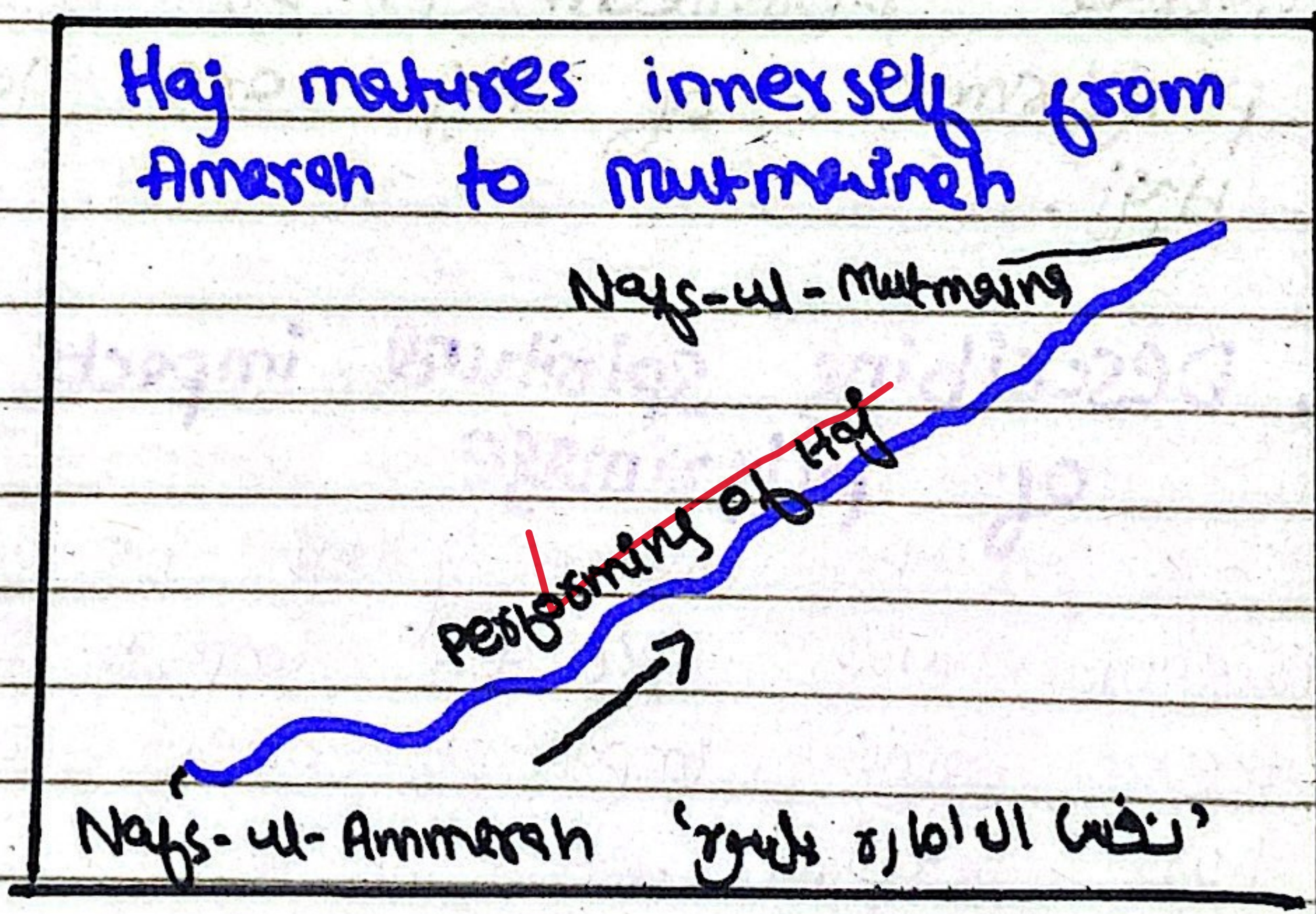


3.1, Purification of Soul

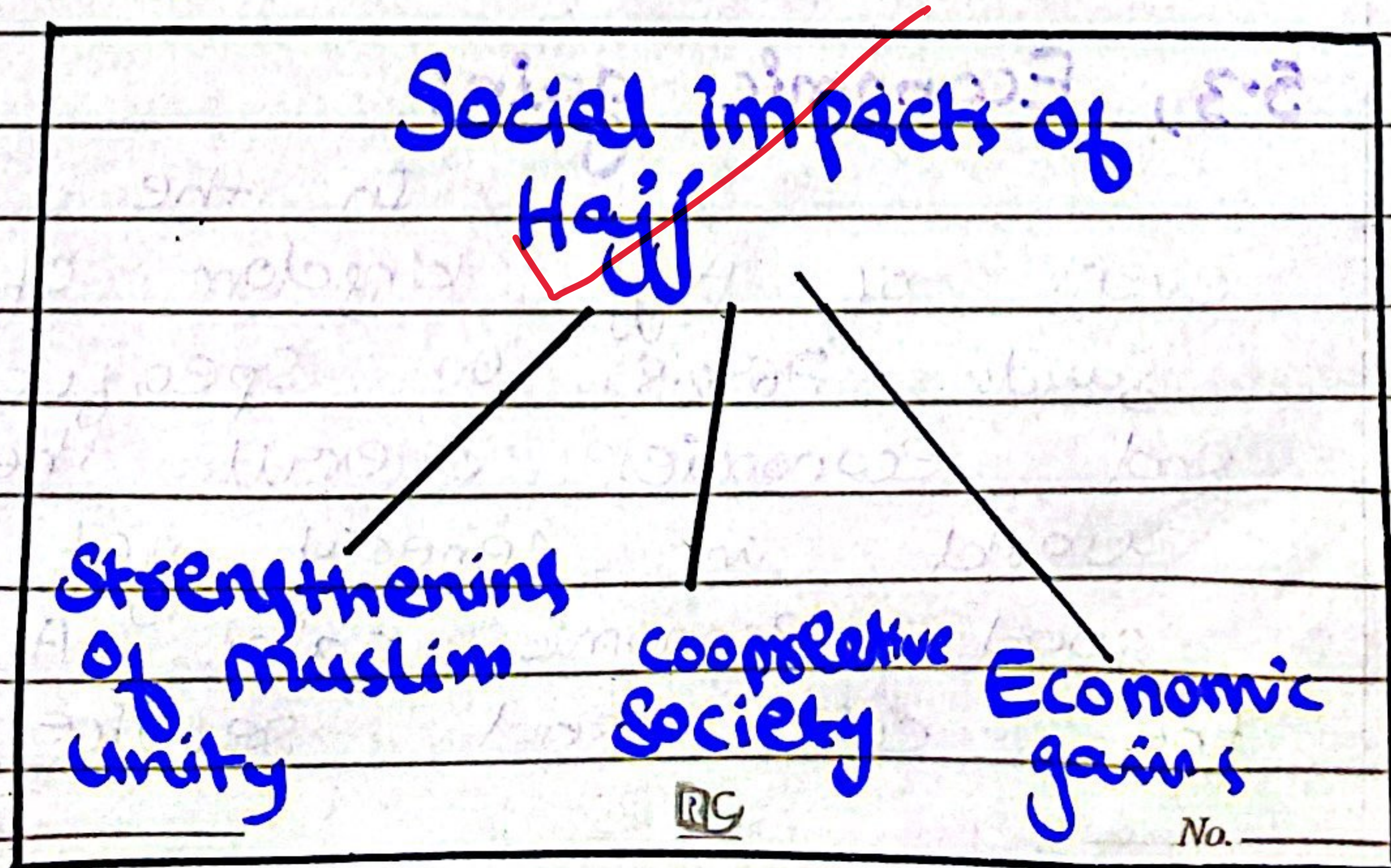
