## 3. Identify the Crime Scene Dimensions

It includes the safety measures to rescue the



victims or to take steps

- Rescue services to minor or serious injured persons
- Transfer of dead bodies to the hospital

According to "Locards Principle"

witnesses must pick or leave some material from the crime scene

So, Investigation officers may keep an eye on witnesses and thoroughly analyze the crime scene.

"Weather Conditions" also needs to identify.

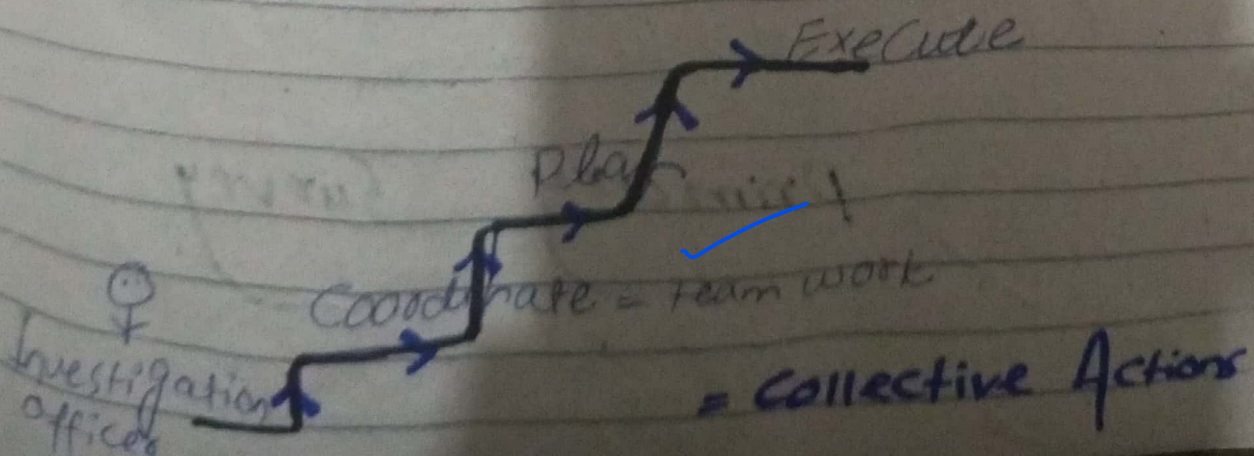

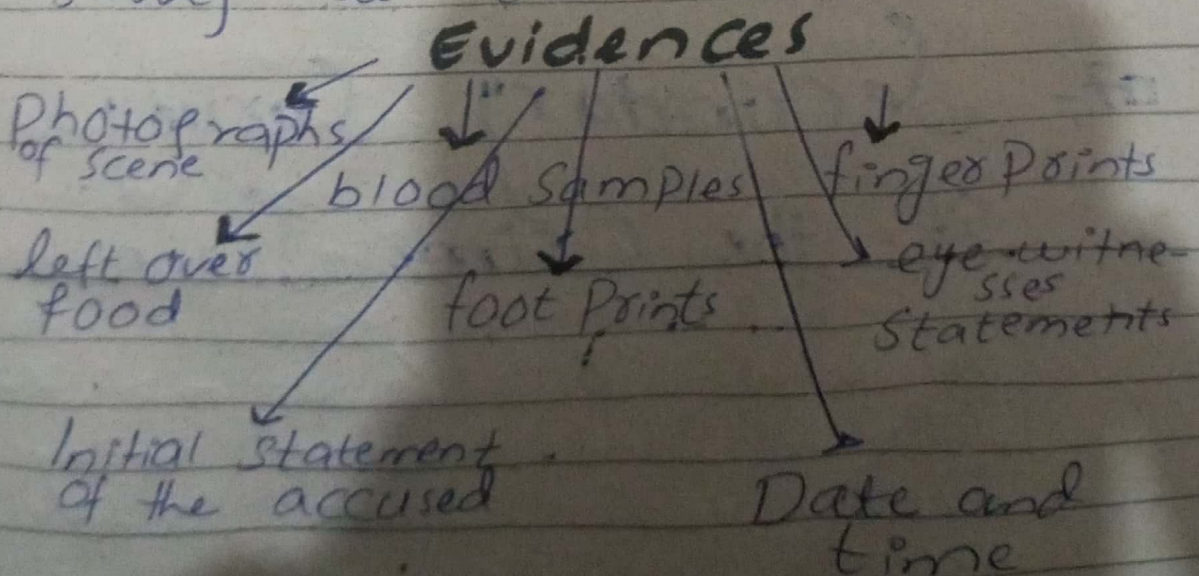
## Example

## Q6 : Collection and Documentation of evidences

Evidences are collected by the start of the primary survey at the crime scene.





After the collection of the evidences, they have compiled in the shape of document. Since the documentation only done after the analysis of the evidence, so investigation team revisit and analyze the crime scene in a proper manner.

### Example

**172 Crpc** Section **172** of Crpc Obliges the police to maintain investigation register of the Cognizable Criminal offences.

## 07- Secondary Survey of the Crime Scene

In order to leave no stone unturned, the police may revisit the crime scene again following the Locard's principle of exchange.

The Secondary Survey would be purposefully done that might give some more clue / evidences for the case.

## 08. Record and Preserve Evidences

After collecting evidences the investigation team may record and preserve the evidences. It may be done through:

- Scanning the evidence
- Record the initial & final statements of the offender
- For example: The scanning of the offender photograph and match it with available criminal data that



the accused might have some criminal record.
