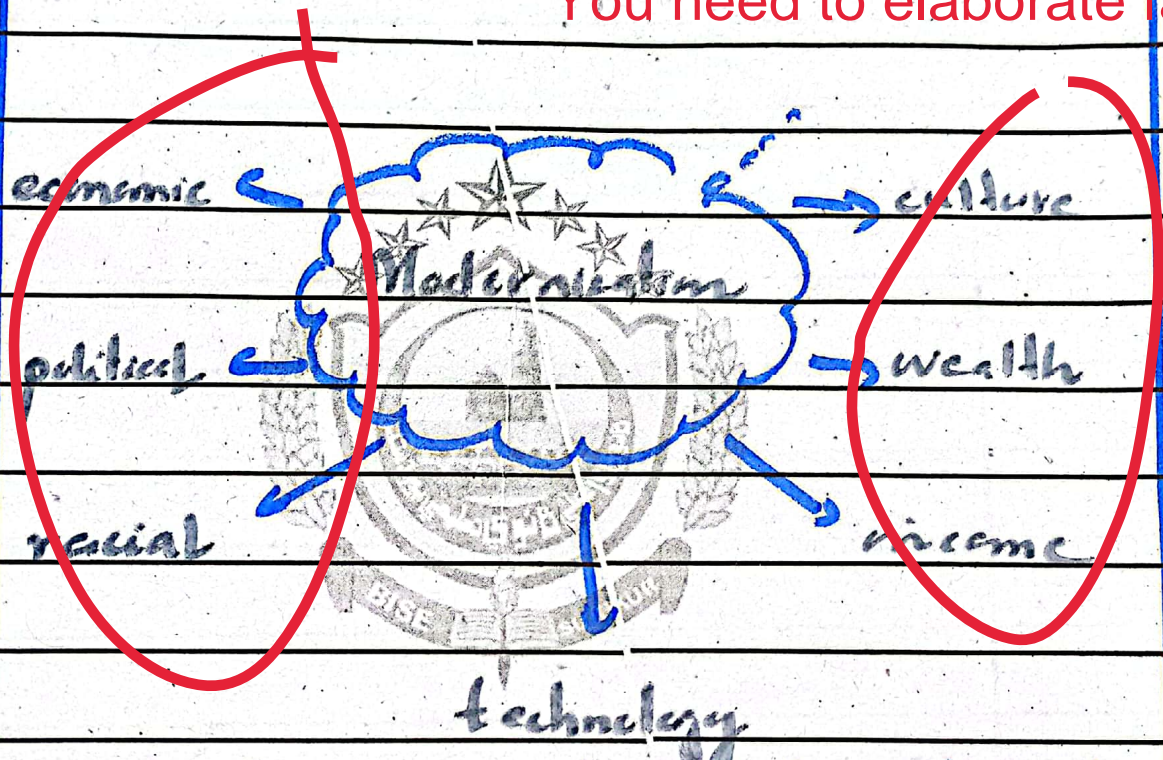

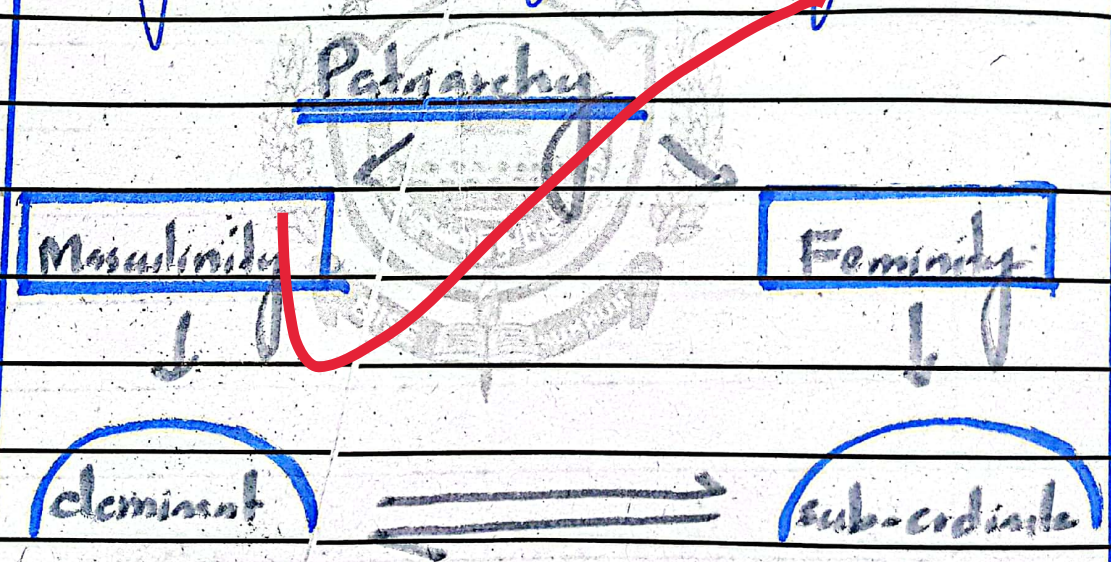
Traditional role

ii) Concept of honour

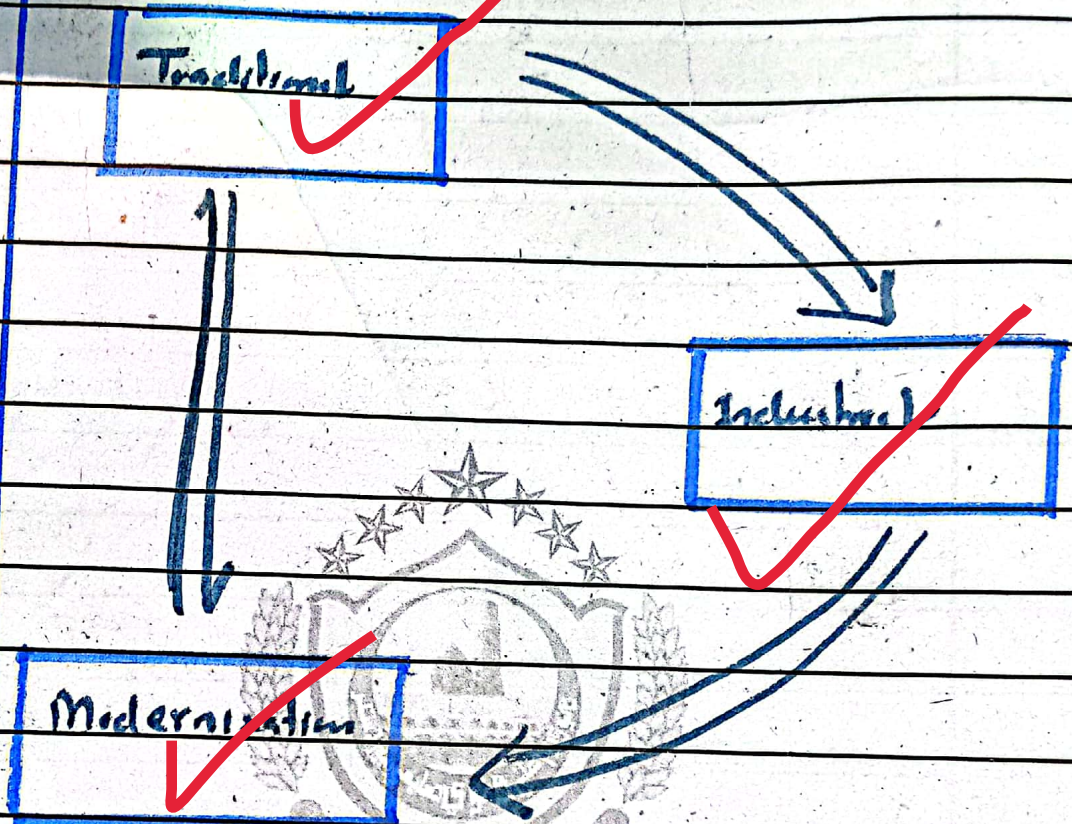
Similarly, concept of honour is also associated with men. This shows how women are exploited in the name of honour.
