Reasons for it to fail can be various. Some of the important factors are lack of awareness of citizens which about democracy democratic norms which can hamper the process of democratization. Moreover, feudal system and intervention of nondemocratic forces in the realm of decision making can shake democracy to its root in third world countries. However, these problems are fixable. Certain measures like digital awareness campaigns, Intra-party election, and Referendum can be used to undo these daunting effects of democracy and make democracy the best revenge.

Instead of referendum, strengthening of institutions is more solid argument

The earliest version of democracy can be found in the form of Athenian democracy which was a form of direct democracy. However, in middle ages democracy largely waned, but it saw its revival during Renaissance. Over the period of time the concept of democracy was evolved with help of American and French revolutions in the 18th century. This was the first time democracy was seen as a revenge. Additionally, in 19th and 20th century the drive to increase suffrage and broadened the realm of democracy as a weapon to gain equality. Apart from that anti-racial movements in 1950s and 1960s cannot be forgotten which through the help of democracy tried to counter racism.



Democracy is the best form of governance to several reasons. Firstly, for a state ^{has} to function in a manner that ^{it} serves interest of its citizens in the best way possible. It is not possible without citizen participation. Hence, citizen participation is only possible when the citizens believe that there say matters in the ruling of the state. Thus, the citizen participations hikes when democracy comes in to play. As it is evident from the fact that the voter turnout in USA was 70% in elections of 2018 and the voter turnout in Pakistan was 35% in elections of 2002 which were held under a martial law regime. It can be said that democracy incorporates the will of citizens in a more effective for running the matters of state.

Secondly, non-democratic forces are always eager to grab the power of the government and undermine the writ of masses. Thus, democracy with its effective electoral system can elected such competent legislators, or executive in form of presidential system, who can control such non-democratic forces. For instance, in USA president has powers to dismiss any general of the army. This was evident when Harry Truman dismissed Douglas MacArthur during Korean wars. Hence, it can be said that democracy strengthens the functioning of state and keeps authoritarian elements of an state



under check.

Thirdly, ~~the~~ human rights play a key role in the security of its citizens. A state that ~~lacks~~ lacks basic elements of human rights can never display the will of its citizen is a jail. However, these right are suspended or are only verbally granted in the case of dictatorial regimes. As in the case of North Korea or Republic of Congo. For instance, Donald Trump was voted out of power by citizens of USA; due to his racist policies. Sixthly, National integration is the key factor for survival of a state. However, it is weakened due to several factors, but the most important factor to weaken it is nationalist tendencies present in a state. For instance, in Pakistan presence of parties like Jeay Sindh or SUP which were able to mobilise enough people to cause massacre in Hyderabad in 1943. These type of nationalist elements are kept under check with help of democracy, as it gives everyone its due right.

Lastly, Freedom of press which gives voice to the citizens are is efficiently maintained in a democratic system. It acts as an important element to strengthen democracy and empower its citizens to get their due share in the state.



It is evident from certain statistics that citizens of a democratic state have more freedom of press than a non democratic state. For instance, as per RSE ranking of Freedom of Press²⁰²³ of USA is 45 out of 180 and ranking of North Korea is 180 out of 180. Citizens can express their views against the people in power under democracy which acts as a perfect revenge under democracy.

Everything in this universe has flaws, so does the democracy. Thus, it can fail to act as a perfect revenge. Lack of ^{political} awareness of citizens of a state can hamper democracy from acting as a perfect revenge. As people who are not politically aware can tend to support populism which can bring a country to brink of a collapse. As it was seen in the case of Nazi Germany, where Hitler gained support and ~~used~~ ethnic waged a world war. Moreover, it can bring a state lack of political awareness can daunt the law and order of the state, where populist misuses the power granted to him by voter. As it was seen in the capital crisis of USA 2020. Thus, democracy can fail to act as a perfect revenge where the masses are not politically aware.

Secondly, feudal system or bradri system is present in South Asia. This can be a problem for democracy to survive in an effective way for citizens to take a revenge.



As the seeds of these systems lead towards ^{electable} ~~electable~~ politics which murders the national politics. For instance, in Pakistan ~~electable~~ ^{for electable} politics is quite prominent. If the list of families that are present in politics since the inception of Pakistan was to be compared, it can be seen that 40% of same families have been ruling since since 1947. Thus, electable politics is a great problem that is born due to feudal or Bradiri systems. Hence, it weakens democracy as a mechanism to be effective in taking revenge.

Thirdly, in third world countries there is a huge influence of non-democratic forces in policy making of a state. These forces are highly professional, institutionalised, and competent which allows them to propagate and use force to come in power and topple democracy. As, it was seen in Pakistan in 1958, 1977, and 1999, where three martial laws were imposed. Hence, it can be said that influence of such force can hamper democracy as a tool to effectively take a revenge.

Lastly, ^{national} Policy Continuation is a very political subject which can hamper the development of the a state. In the case, where ^{of third world countries} populism is practiced mostly, policy continuation becomes a problem. This can hamper development of a state. For instance,

in case of Pakistan, an important agreement, CPEC, came to a halt. This occurred due to lack of will of elected government to follow the policies set by the previous government.

However, every problem has solutions, so does these problems. Firstly, direct control of armed forces model can be used to control the non-democratic intervention in decision making. This can be done by giving non-democratic forces a say in the decision making which is recognised legally by laws of the nation. This can effectively counter the non-democratic intervention. Thus, making democracy more suitable model for third world countries.

Secondly, Digital awareness campaigns can be used to counter undemocratic mentality of the masses. Mostly, in third world countries, citizens are not aware of their power to bring a change with their vote.
