

Define the term Crime and Criminal. / Explain the types of Criminal in detail.

Crime:

Crime is an everyday phenomenon of human life. It's as old as human race itself. However the term "Crime" according to Merriam Webster Dictionary, owes its origin to Latin word CRIMIN which means accusation. Subsequently

The term "Crimen" was used in French, during 12th Century" Connoting "fault" or "Sin".

The Oxford English Dictionary defines the term Crime as under:

"An action or omission which constitute an offence and is punishable by law.

Criminal's

Criminals are individuals who commit Crimes. A Crime is an act that violates

law and is punishable by the Criminal Justice System.

A Criminal Act occurs when there is a motive, a means, and an opportunity.

August Dredhms Classified Criminals under 3 main heads, Instinctive, habitual and single offenders

1) Instinctive Criminals

Who cannot adjust themselves to the social order on account of hereditary or inborn defects.

2) Habitual Criminals

Individual who regard the systematic violation of the law in the light of an ordinary trade. Include those convicted of theft, fraud, arson, forgery and blackmail.

3) Single Offenders

Socially normal person who has not yet formed any criminal habits, but who has committed single offences.
