Interpol, the International Criminal Police Organization was established in 1923 to facilitate international police cooperation and combat transnational crime. Interpol's strategy aims to reduce the impact of serious, organized and emerging crime through enhanced law enforcement information exchange, actionable intelligence products and enhanced law enforcement and operational support.

Measuring Success of Interpol

1) Disruption of Criminal Network direct measure of Interpol impact

The number of criminal networks dismantled and their leaders apprehended with the illicit operation disrupted serves as a direct measure of Interpol's impact. Interpol has dismantling over 12000 criminal network since its inception. Interpol's databases contain over 170 million records on criminals and criminal activities, According to Interpol.

For Example:- In 2020, Interpol has dismantling the "Ndrangheta" a powerful Italian organized crime group. The operation led to the arrest of 430 suspect and seizure of over 1 billion euro assets.

2) Seizures of Illicit of Good by Interpol

The volume of illicit goods such as drugs, weapons and counterfeit products seized

through Interpol supported operations ~~indicated~~ indicates the effectiveness of disrupting criminal supply chains. In 2021, Interpol supported the seizure of 874 tonnes of illicit drugs, 35,000 illegal firearms and over 15 million counterfeit products.

For Example:- In 2021, Interpol coordinated Operation Pangea XVI, a global operation targeting the trafficking of counterfeit pharmaceuticals. The operation resulted in the seizure of potentially dangerous pharmaceuticals worth over USD 7 million.

3) ~~Bet~~raditions and Fugitive Apprehension through Interpol

The number of fugitive apprehended and extradited through Interpol mechanisms demonstrates its role in bringing criminal to justice.

According to Interpol Global Crime Trend summary report 2021, Interpol supported the arrest of 1168 fugitive and the extradition of 886 fugitive.

4) Capacity Building and Training through Interpol Programs :-

number of law enforcement personnel trained and the environment enhancement of investigation skills through Interpol's programs indicate its contribution to global law enforcement capabilities.

i) InterPol Global Academy :-

Since its inception, the Interpol Global Academy has trained over 50,000 law enforcement officers from around the world.

ii) InterPol Virtual Academy :-

The InterPol virtual Academy provides 100 online courses in a variety of language.

Conclusion :-

Interpol contributions to combating organized crime are substantial and multifaceted. Its ability to facilitate international cooperation to provide intelligence and expertise and coordinate targetted operations has led to significant disruptions of criminal networks and the apprehension of
