China internally supports and is working on building a Confucian civilization while on the contrary the world is quite apt with the western civilization. The rise of China and Confucian civilization with a popular support can be a threat to the western civilization and as a result it is threatening the world order. In short, the clash of civilizations might change the world order where Confucian civilization becomes the new model of the

Inflation has crippled our socio-economic progress

The socio-economic progress of a state depends upon multiple factors including its literacy, security and overall political dynamics. However, one of the biggest causes of a state's progress is its financial standing as it leads to social as well as economic progress of a state. Over the past few years, due to multiple reasons, Pakistan has been a prey to inflation which has crippled the socio-economic progress of the country. On the outer side,

However, there are multiple interconnected evidences to prove that inflation has become the worst enemy of Pakistan's socio-economic progress. From the deterioration of domestic living standards to shutting down of businesses, inflation has taken toll of the overall socio-economic fabric of Pakistan.

As redundant as the word 'inflation' seems, the world has collectively borne witness to it. Just like the great depression and global recession, the world is once again facing a record breaking inflation due to the Covid-19 pandemic followed by the Russian war on Ukraine. These one after the other global events impacted the overall economic progress of the so-called globalized world, which trickled down to underdeveloped countries with a higher intensity; Pakistan is one of them. The global inflation

individually impacted countries, and coming to Pakistan. It has various negative impacts on the overall progress of the country. Just like the world, this inflation has hit Pakistan making it go through tough times, like Sri Lanka did.

The first and direct impact of this inflation globally led to the dwindling of currencies across the world. In lieu of that, the Pakistani rupee devalued with a visible margin. As the world revolves around a standard currency, i.e. dollar these days, the devaluation of PKR has a negative impact on the socio-political and specifically the socio-economic progress of the country. This devaluation has reversed the reserves of people as well as the state. The loans on the state increased because of the devaluation in currency and as a result, the increased loans led to an added pressure on the masses in the form of hefty taxes and additional cuts.

Stable economy is a dream of any investor, and this boom and burst cycle of the changing value of PKR discourages both foreign and local investors from investing in businesses in Pakistan. The foreign direct

investment decreases, and simultaneously the local investors also hesitate because of the unpredictability of the value of PKR against dollar. This unannounced rise and fall, impacts the socio-economic progress of the country because the world is modernizing but in Pakistan, the fear of collapse of businesses does not let the investors invest in the first place. As a result, the progress that a society sees with economic ventures seems crippling in the country right now.

Not only the trust of investors, but also the pockets of locals have been shaken by the current inflation. Electricity prices have sky-rocketed due to multiple reasons including the overall increase in fuel prices across the globe and hefty taxes imposed by the government which led to an unprecedented rise in electricity bills. This has crippled the socio-economic progress because a major chunk of money in domestic budget as well as industrial budget goes to paying bills. As a result, in the past two years, electricity bills have been a major point of attention while addressing the issue of inflation. Not as simple as it seems, electricity is the basic need

and the inability to afford it leads to the crippling of socio-economic progress.

The irony is that the inflation does not stop at electricity bills, instead the rise in fuel prices leads to a rise in prices of all commodities of domestic and industrial use. From edible oil to mobil oil, everything has gotten expensive, challenging the purchasing power of the people. This is the first time in the history of the country that despite a major power parity in the society, every sector has been hit hard by the inflation. As a result, when the production cost of industries increases due to inflation, the commodities get expensive and locals cannot purchase it. This leads to the crippling of both socio-economic sectors because their needs are symbiotic with each other's progress.

The inability to meet one's needs leads to a rebellious state of mind, full of aggression. As a result the society's stability reduced to unease leads to an overall unrest in the society. This unrest includes multiple protests against

As the local industries got hit, the production in the country was not enough to meet the needs of people. This led to an increase in the imports and decrease in exports. Increased imports bring with them increased prices with taxes and tariffs and an overall increase in the trade deficit. As a result, reduction in exports and an increase in imports led to the reversal of socio-economic progress as not only people were hit by higher prices but also the industries were targetted leading to a huge burden on the state's economy. Hence the trade deficit and increased exports impact the

Another impact of closed industries amid rising inflation is unemployment. This unemployment or stagflation, instead of making the youth a strength, makes it a burden for the state. Rising number of jobless people leads to the socio-economic deterioration of the state because not only are they not contributing to the country but also, at the same time they are suckling on what the state has. As a result, instead of lifting the state, they become a burden. Amid inflation, the state cannot create multiple jobs for the people due to its economic limitations, and as a result unemployment leads to an overall socio-economic distress in the society.

Once a person does not find a job, there are high chances of him looking for unfair means to make both ends meet. In case of unemployment or lower salaries in this time of inflation, many people

At social level, it includes theft, robbery, or corruption and at state level it leads to money laundering, gambling, embezzlement, and other white collar crimes. The state that gave them subsidized education and skills, bears the brunt of its flawed system that led to the exacerbation of inflation, crippling the socio-economic progress of the state.

Only because Ukraine was backed by the global powers in the west, every human rights violation was taken into account making it a huge issue. On the contrary, since October 7th, 2023 not a single condemnation of the humanitarian crisis in Gaza has been received from those countries. This shows how on the surface, people are equal but based on interests, and ideologies some men are definitely more equal than others.
