According to the Economic Survey of Pakistan 2022-2023, Female literacy rate in Balochistan is 36 percent. Women faces difficulties in registering FIRs in Pakistan. Women have to face different kinds of harassment during court procedures. There are very few women who are police officers. There are no separate gender protection for women in all the cities. Corruption is also another element which restricted women from participating equally in the judicial procedures.

According to the Punjab Police, there are only 10% women who are part of Punjab Police of Pakistan. It means that women who represent half of the total population of Punjab have only 10 percent representation in Punjab Police. This shows that women faces gender-biasedness in laws and court procedures in Pakistan.

Similarly, Pakistani Political Institutions are dominated by men. Women are not allowed to take part in Politics in Pakistan. All the



Political institution of Pakistan are run by men. Those women who take part in politics faces severe criticism. Women are discouraged to participate in politics by their character assassination. Women are also faces different kinds of harassment in political party. According to Economic Survey of Pakistan 2022-2023, Only 17 percent women are parliamentarian in Pakistan. This demonstrate that women faces difficulties while participating in Politics in Pakistan.

In the same manner, Women are not allowed to participate in high level decision making process. Women are considered as a second class citizen in Pakistan. Women remains deprived of different kinds of facilities in Pakistan. Only a few women represent important seats

Important department such as Finance, commerce, technology and many others, are held up by men in Pakistan. Women are not considered as eligible for that important position.
