a) Difference in ideas of bureaucracy

7- Political System experienced by Woodrow Wilson

Woodrow Wilson experienced that bureaucracy is away from political activity.

Moreover, he also emphasize on the distance of bureaucracy from political affairs.

"Bureaucracy must stay away from politicking, politics is not permanent, but a bureaucracy is permanent; hence, no room for bureaucracy in politicking."

(- Woodrow Wilson, The Study of Administration, 1924)

Therefore, Woodrow Wilson experienced distinct bureaucracy.

## 8- Political System experienced by Max Weber

Max Weber experienced political system in the need of bureaucracy. He experienced that no progress will be observed if bureaucracy is indispensable.
