### b) Protection of public realm

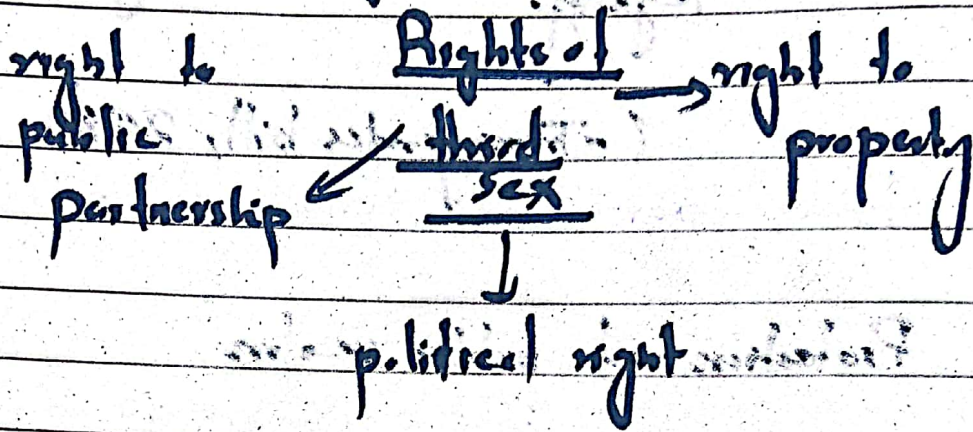

## 2. Definition of good governance

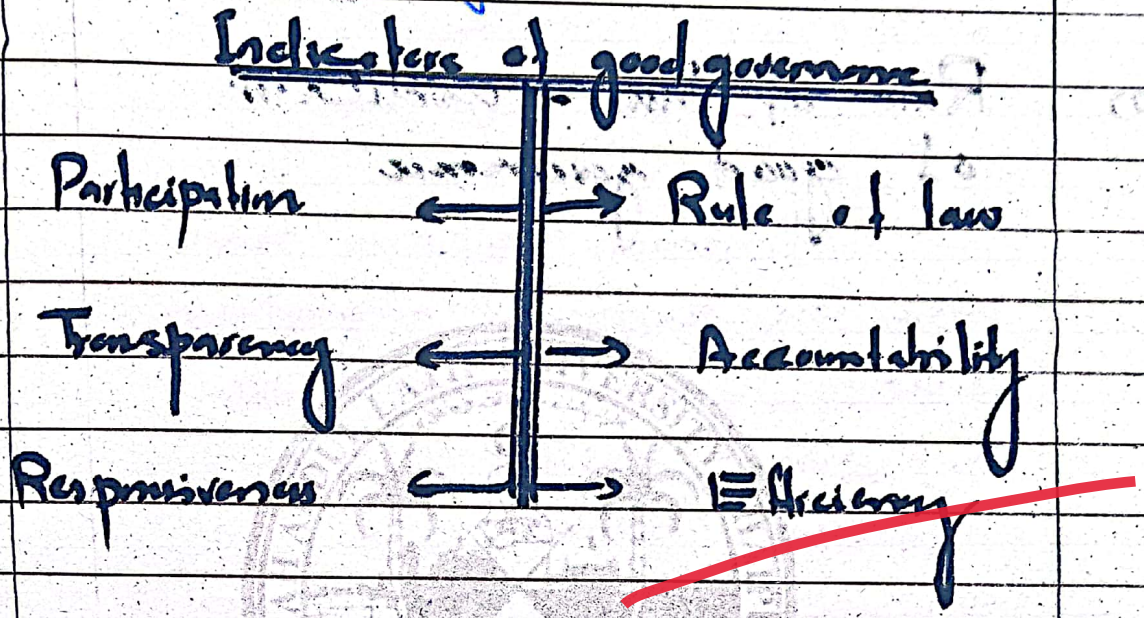
"Good governance prefers policies of long tenure to achieve human development and economic sustainability"
