legislative body has

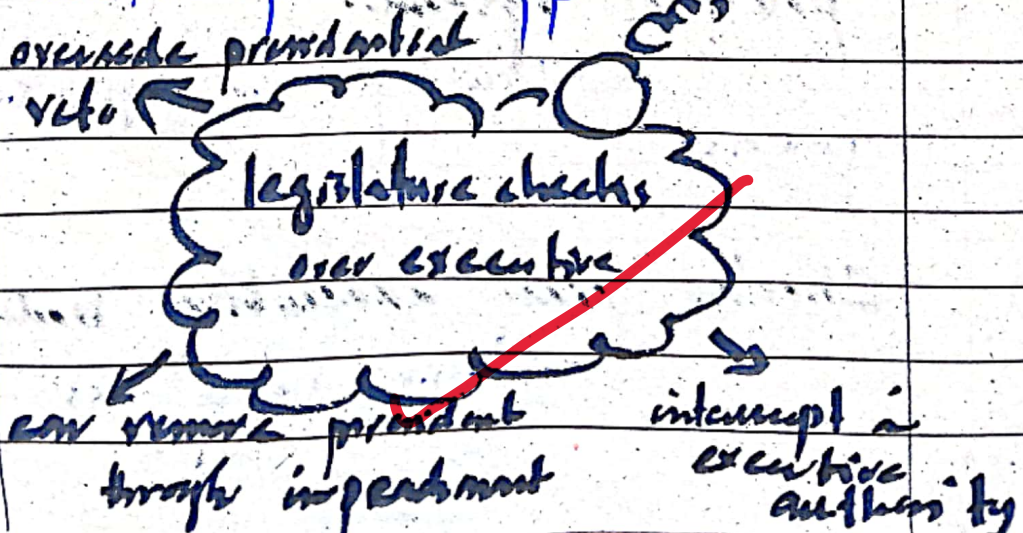

 majority of senate."

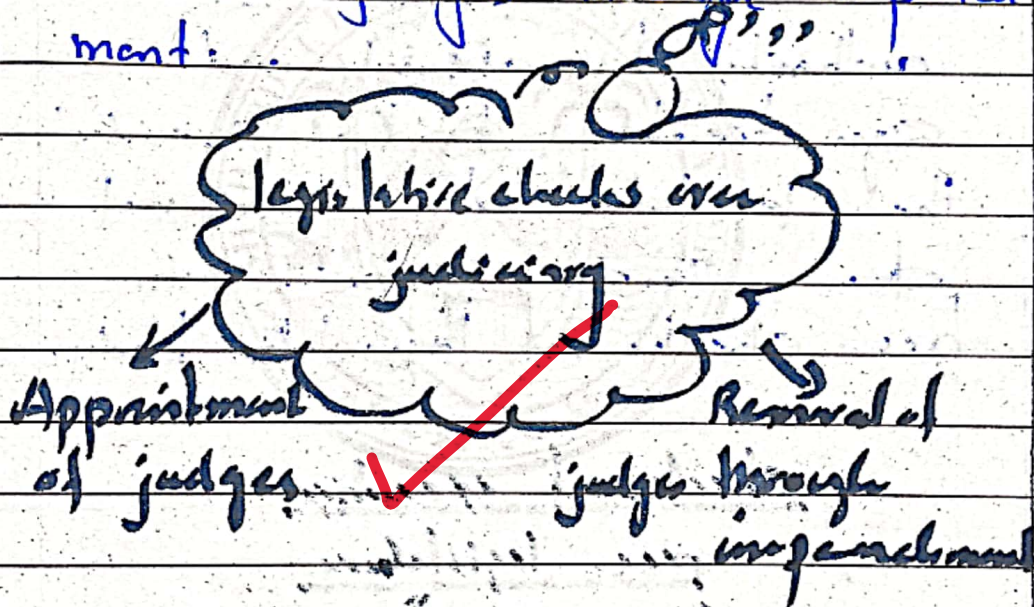

Moreover, legislature has
 also power to impeach
 president's authority and can
 remove him through
 impeachment. Not only this,
 but legislature can also
 interpret in executive
 authority of foreign affairs
 and in special appointment.



b) Checks over judiciary authority
 legislature body has also
 checks on judicial authority.
 Chief among is in appointment
 of the Supreme court judges. In
 fact, appointment of the SC judges
 by president is approved by
 Senate of congress. Moreover,
 the legislature has power to
 remove judges through impeach-
 ment.



4- Executive powers of the US
 political system
 Executive powers are
 discussed as below:

a) Checks over legislative body
 Similarly, executive body

has checks over legislature.

Main among is 'presidential veto', president can veto the law passed by legislature.

"the US president is powerful in the world."

Secondly, the executive has authority to appoint and sign treaties. Without president, the legislature alone can not do. Therefore, executive also has checks on legislative body.

Judiciary like legislative and executive authority also has checks on both. In fact, judiciary maintains the supremacy of law.

over legislature.

b) Checks over executive body

Further, judiciary also
has some checks on executive
powers. In fact, law passed
by congress and signed by
president has no power
in case if it violates
constitutional value. Resultantly,
checks of judiciary works and

override the law signed by president in order to protect the constitution.

Therefore, judiciary also has checks on executive body.
