Travis Hirschi argued one
can not commit crime if one

society. According to ✓ him,
every individual has potential to
commit crime, but fears - a bond

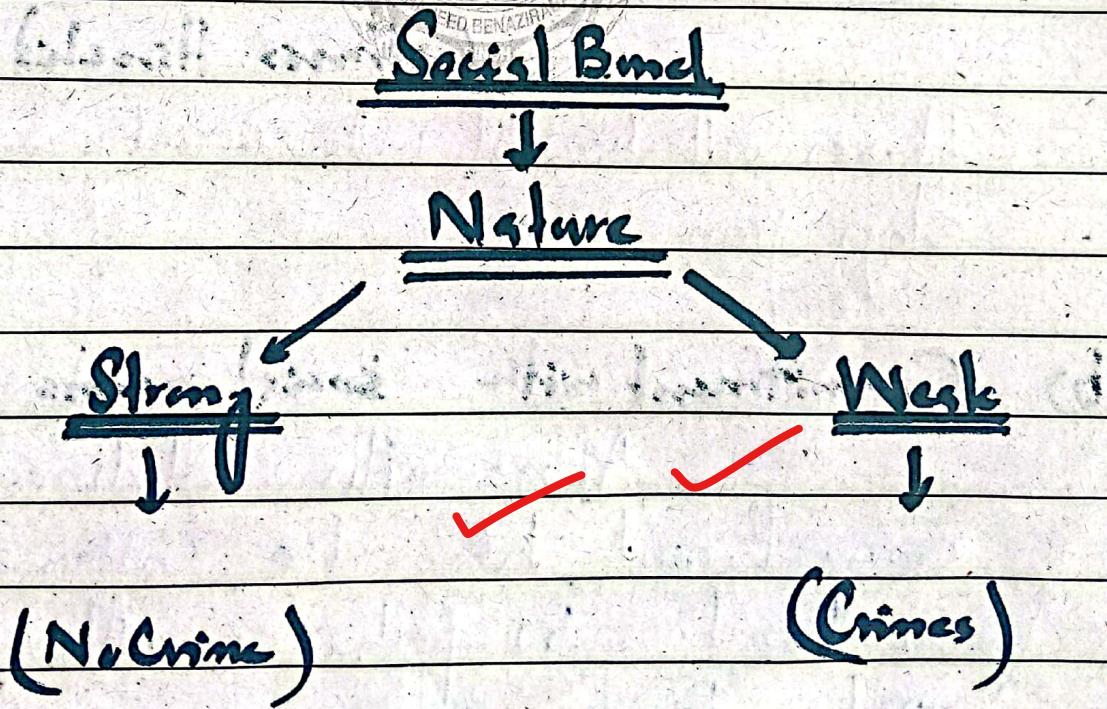


stop a person from committing crimes.

In his book, "Causes of delinquency", he told that a strong bond of individual ~~put~~ down criminality..

(- Travis Hirschi, Causes of Delinquency, 1969)

Therefore, a strong bond prohibit from crimes, while a weak or broken bond leads to crimes.





4- Elements of Travis Hirschie's Social Bond Theory

Following are elements:

a) Attachment with society

Attachment with society protect one from crimes.

In fact, a strong attachment leads to a strong bond.

"Attachment with parents, peers, and community leads to strong bond."

(- Travis Hirschie)

Hence, attachment with society stop from crimes.

b) Commitment with social norms

Along with attachment, commitment has also influence on bond. In fact, commitment makes bond stronger.

"Once commitment with effort, future goals, and success leads to a strong bond."

(Travis Hirschi)

Therefore, commitment is another factor of strong bond relation.

c) Involvement in social characteristics

Involvement in society leads to ~~social~~ social bond firm. A firm social bond leaves almost no space for crimes.

According to Travis Hirschi,

"To obey rules,
To be honest,
and

To be responsible
makes a strong
social bond."



Therefore, involvement in society makes strong relationship.

d) A strong belief in social norms

Furthermore, a strong belief encourages society. People involve and make society trustworthy.

"Certain seminars, religious gatherings and

social interaction

gives birth to faith in social values."

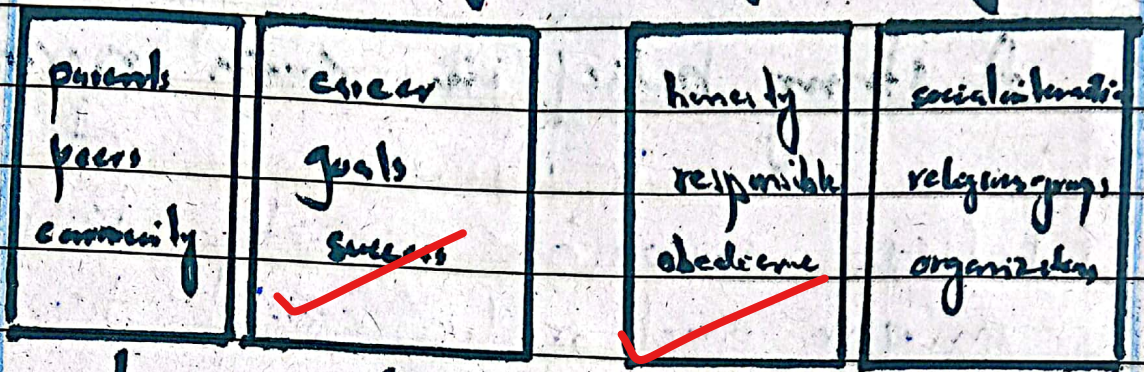
(Trans Hirschi)

Therefore, a strong belief in social values makes a strong bond between people and society and prevents from crimes.

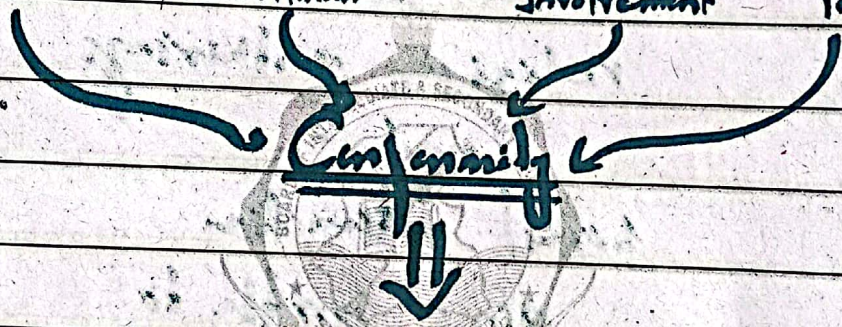
Following is a pictorial representation:



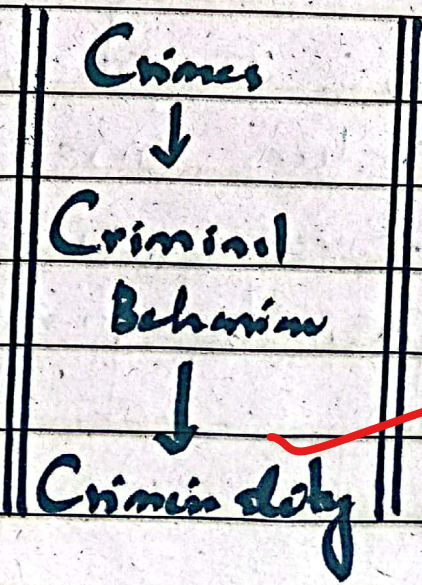
Elements of Social Bond Theory
