3) Drawback of tradition classical institutions:

c) Classical learning lack Audio Visual AIDs:-

In developing countries, basic necessities of educational institution are not fully present. with exception of some comparatively developed areas of these countries, others are deprived of audio-visual ~~AIDs~~. In absence of these aids students cannot clearly their concept about topics and most students just made blussed image about topic in minds, but in onelive learning Audio-visual AIDs can

be used easily and students can make clear image of concept in their minds.

d) Classical/traditional learning is mostly teacher-centered;

Teachers mostly provide instructions during period to the students in classical learning and students interactions remain at minimum level. But in contrary to it, presentations, project and other activities held online increase the skill of students.
