Overall, the legislation provides \$ 27.0 billion for the federal student aid programs and another \$ 3.43 billion for higher education programs, an increase of \$ 889 million from fiscal year 2021. That shows the difference between the spending of developed and developing countries. The developed countries are increasing their spending on education but the developing countries like Pakistan is decreasing their spending on education sector. That is cause of major difference between the economies of both ; the developed and the developing countries' economies and their standards of living.
