But this league of nation known for its failure. Then important meetings are held leading to UN formation after world war II. It was founded in 1945.

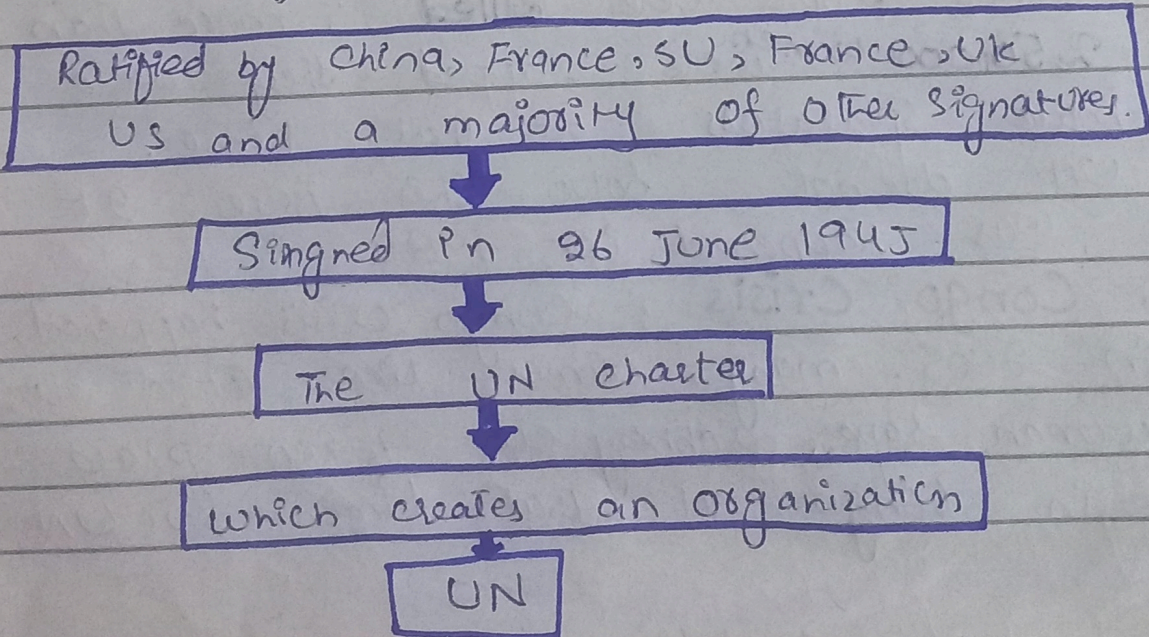
Its original members were 51 but currently members of UN are 193 members.

- ④ To be centre for harmonizing the actions of nations to achieve these goals.

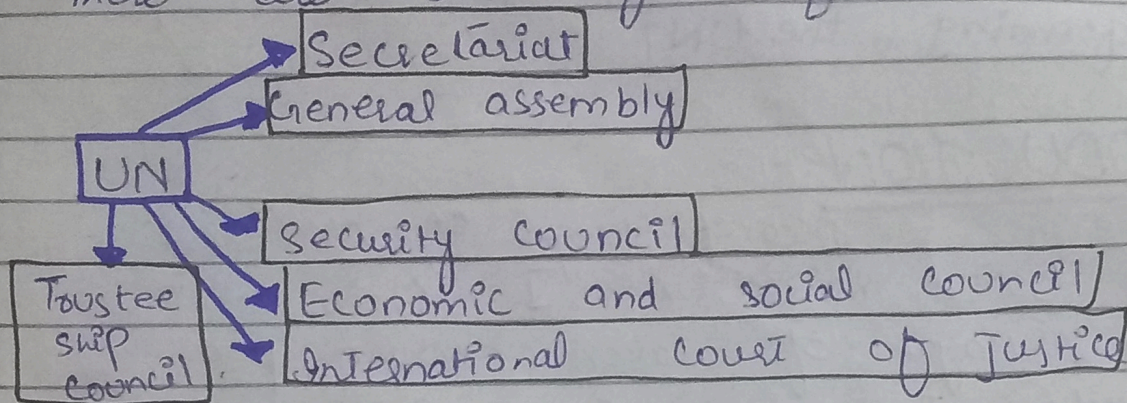
FORMATION OF UN:

50 countries gathered in San Francisco in 1945 to sign a document UN Charter.



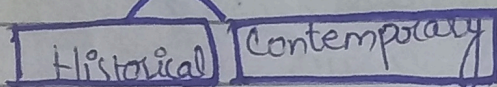
ORGANS OF UN:

HISTORICAL FAILURES OF UN

① Rawadan Genocide: It is the biggest failure of United Nations. UN has seen this genocide earlier. They took the preskipping forces to Rawadan before disputes there are two tribes Houthis and Tutsis exist there. At the present of preskipping forces genocide took place. more than 800,000 people were killed; more than 2,50,000 women were raped. they were male spectators at that time. UN doesnot solve this issue. It was happened in 1994.

② Congo Crisis: Congo crisis happened in 2005. many crimes like child abuse woman rape, robbery etc taken place in Congo at that time. so UN

send their forces to Congo to stop them. After some time they stopped everything and went back to their own countries. Then investigation starts that why all these crimes were taken place. After investigation, UN pre-emptive forces which were sent to Congo were themselves involved in all these crimes. It was named that Blue helmet sex scandal. It was a biggest failure as far as UN is concerned.

③ KASHMIR: Kashmir is the oldest unresolved, accepted dispute by the United Nations. They gave 17 resolutions on Kashmir but it cannot be solved.

CONTEMPORARY FAILURE

① Failure to curtail the world powers
You have written in the UN charter Article No 1: maintenance of international security is the first and foremost objective of UN. But they fail to maintain world peace like Afghanistan crisis, Cold war, Indo-Pak war, UN missiles crisis, European intervention in Syria problem. They are unable to curtail the world powers.

② CLIMATE CHANGE: Since the creation of UN this problem was there. UN did not take any productive measures if they take measures then world

powers denied the measures the UN.
Example: ¹⁹⁷² 1972, UN ~~law~~ make Commission
UNEP, Kyoto protocol.

③ Palestine - Isreal: the main and
important failure of UN, Pre 1967
border between Palestine and Isreal
should be restored. UN nations
did not do anything.

④ Refuges: UN have proper Commission
named UNHCR. but no mechanism
is seen that the refugees of different
countries go their own homeland
like shelter. fails to provide facilities
to Refugees.

⑤ Human Rights violation: Human
Rights violation exist all over the
world like Myanmar, Yemen, Somalia,
Latin America. UDHR called Universal
Declaration of human rights in 1948
but this there is seems that
no chance of implementation UN
cannot be doing anything of entire
idea of Human right violation.

SUCCESSSES OF UN

① NO WWII the biggest success of UN
is world war does not happen. UN
fails but because it does not stop entering
the world war II. Although we all are
pay cost after the creation of UN

but we have seen Cold war, Iran revolution etc but somehow involvement of ~~was~~ UN stops the world entering in world war III e.g. Cuban missile crisis, UN and USSR were very close to the war of nuclear weapons. Unfortunately, there was an misunderstanding created between them then UN played their role to solve all these misunderstandings, two treaties were signed between USA and USSR SALT I, SALT II (Strategic Arms Limitation Treaty). Because of these treaty more than 10,000 military weapons were disposed off.

② SPECIAL CRIMINAL TRIBUNALS: There are some tribunals they thought that no one encounter them but when UN were formed they encounter the tribunals

SPECIAL CRIMINAL TRIBUNAL TO SERBIA:

Serbia dictator Slobodan was accused of more than 100,000 more people in their own country but he was not answerable to anyone. UN prosecute him but he died during the prosecution

SPECIAL CRIMINAL TRIBUNAL TO LIBERIA:

Charles Taylor was also accused of more than 100,000 people in their own country during civil war. He was prosecuted by UN on special Criminal Tribunal to Liberia. He was sentenced to 50 years of imprisonment.

③ Famine and Diseases

UN focused on two things Famine and Diseases. They established two Organization WHO → FAO, These Organization work for Famine, health

④ "NPT": Non proliferation Treaty:

In 1963, UN signed Treaty which named was NPT then establish institutes IAEA. In the Treaty, those countries who signed the Treaty, they developed nuclear technology for peaceful purposes but they did not made any nuclear weapons.
