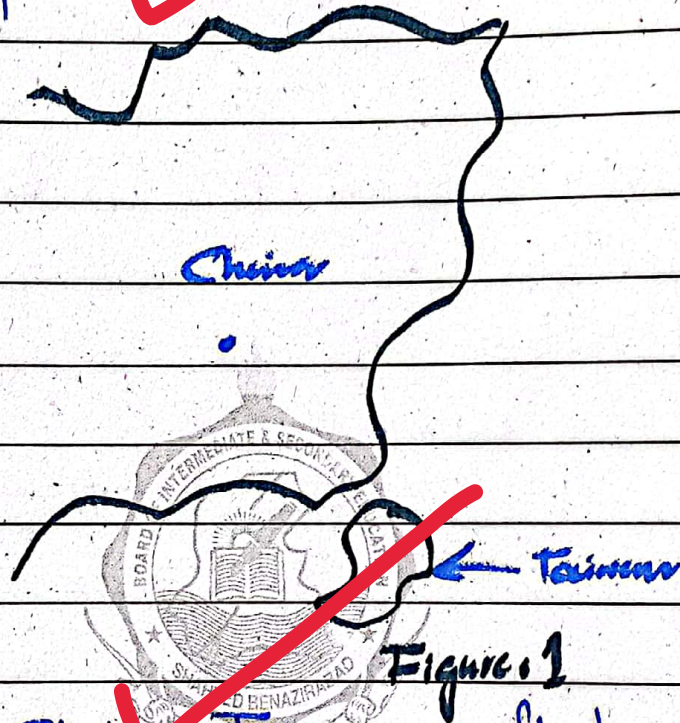
2- A bird's eye view of Sino-Taiwan conflict

China has following

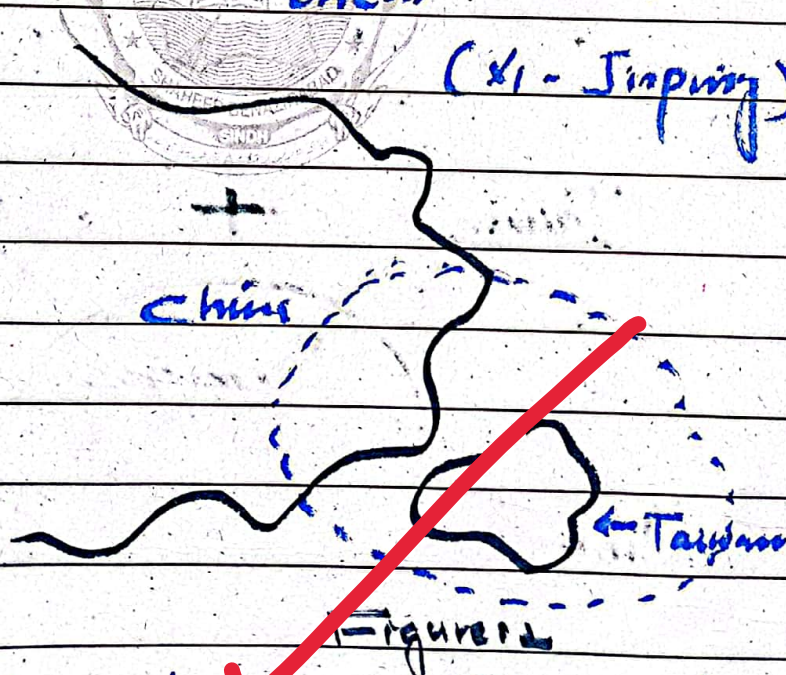
main policies:

Thus, China claims on Taiwan territory.



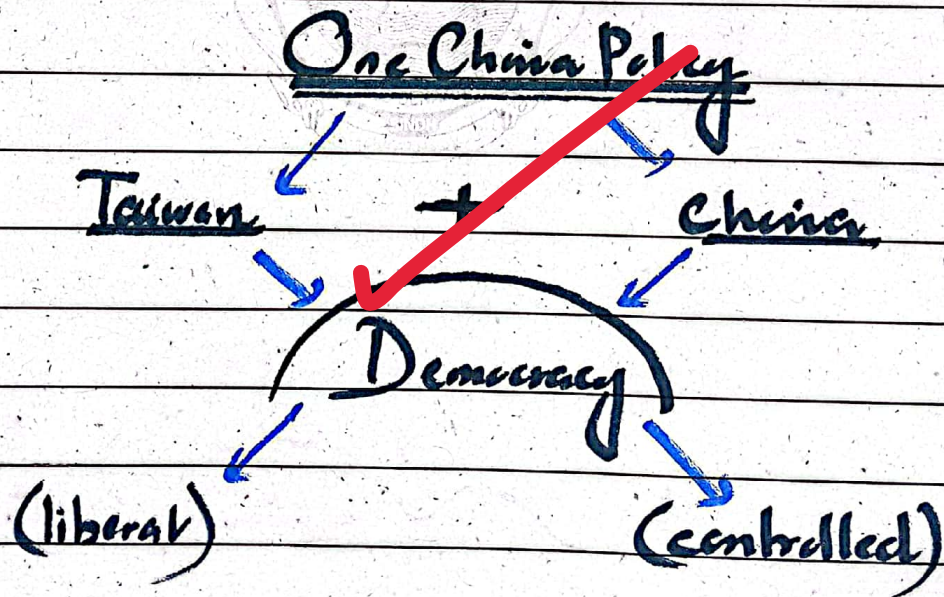
(a) 'One China Policy' of China

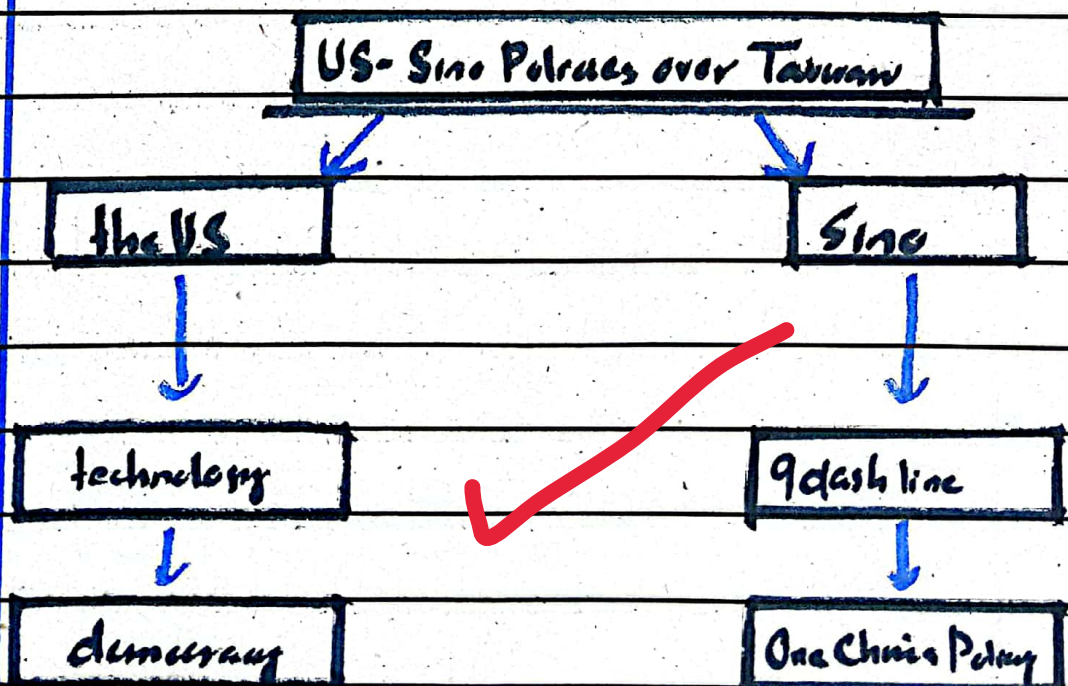

4- Recommendations to diffuse tensions between two global powers

Following are recommendations:

a) Respecting sovereignty of Taiwan

Respecting sovereignty of Taiwan is a major step to normalize conflict. However, China claims over Taiwan; but, peace is in sovereignty.

Sovereignty is a symbol of permanence (Political ideology of John Austin)

Hence, ensuring sovereignty of Taiwan will help in diffusing tensions.

b) Ending hostile ideology between US-China

Moreover, ending hostile ideology can also help in

normalizing relations. In fact, both global powers have a responsibility of maintaining peace of the world.

"End of hostile ideology is a way of peace."

Therefore, end of hostile ideology can also help in diffusing tensions.

c) Ensuring fair right of global trade

Furthermore, fair right of global trade can also ensure peace between two powers. In fact, trade war is a dominant conflict between two powers.
