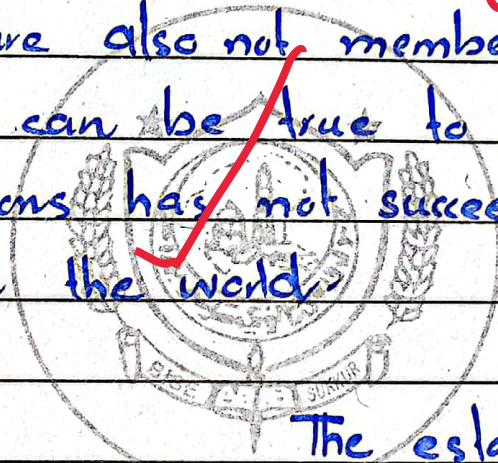

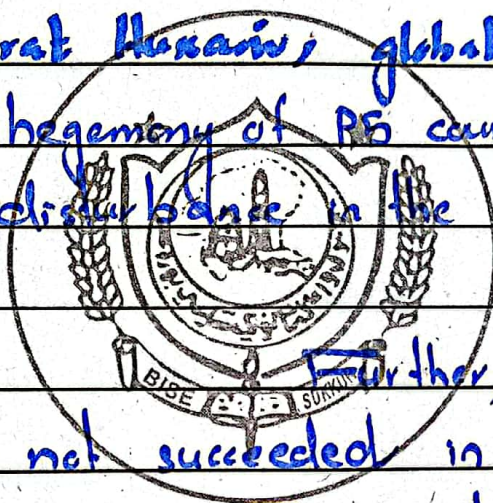

After the WWII, the need of an organization for peace-keeping paved a way for the establishment of the United Nations. "The failure of the 'League of Nations' in stopping the world war

after the WWI led to the world in a new era of WWII." (An overview of background of the UN's establishment). Thus, the United Nations establishment is to maintain peace and avoid wars in the world.

The United Nations has failed in averting war in the world as it has not succeeded in stopping countries from attacking sovereign territories. The United Nations, unfortunately, has no effective control over world powers to stop them from attacking. In consequence, the countries are leading to wars. "Annexation of Crimea, is a huge evidence of discretionary power of Russia that posed threat to Crimes by annexing it in 2014." (The CNN, The World in Perspective, 2020). Thus, the United Nations has failed to stop countries from attacking sovereign territories.

Not only this, but hegemony of P5-countries also leads to peace disturbance in averting wars. In fact, hegemony of P5 is more political interest based. Abuse of responsibility of P5 also disturbs peace of the world. "Veto power of P5 members is personal interest based rather than uniform performance." (Dr. Ishrat Husain, global governance, 2019). Hence, hegemony of P5 countries has led to peace disturbance in the world.



Further, the United Nations has not succeeded in stopping military funds for wars. The countries are more binded with each other in unilateral support. In consequence, one-sided military funds has made peace almost in compulsion. According to the latest report, "NATO and its allies have funded about \$13 billion military fund to the Ukraine in support of war against Russia."

As per the statement of SIPRI, "The global investment for military advancement is reckoned at about \$ 23 trillions in 2023." (The SIPRI, 2023). Moreover, the United Nations has also not averted nuclear proliferation. In fact, the world is more readily moving towards nuclear proliferation. Unfortunately,

Further, the FATF and other organizations have also associated with the UNGA for peace-keeping mission. In fact, the United Nations has a structured framework to avert wars in the world. These organizations have regulations over countries as to search financing purpose

that might leads to wars. "The FATF has recently suspended Russian membership on Russia-Ukraine war." (BBC, 2023).

Therefore, the FATF and other organizations have association with the United Nations for peace maintenance.



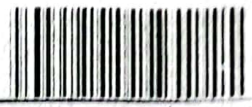
