The evolutionary journey of current world order began in 1946.

During this period, United State and USSR emerged as two great powers in the aftermath of WWII. The world was divided

into bipolar or two blocs: the Eastern bloc was led by USSR and the western by US. It has ended with the fall of soviet union in 1990 which resulted in unipolar world direction dominated by US.

However, American hegemony was challenged by emerging power China who - after discarding its protectionist foreign policy - engaged activity in global politics. Therefore, a new world order emerged to

UAE and Summit. This shows that the world is moving towards multipolarity with varying ebbs of different states.

Moreover, American efforts to contain China paved the way for multipolar world order. The policy was aimed at curtailing its reducing hegemony. However, ironically, their countermeasures boosted multilateralism. This can be ascertained from G7 initiative of BUIZ in 2022. Although, it was launched to counter BRI project, yet it designed in such a way that it unfolded collectivism due to multilateral investment policy by G7 countries. Therefore, new direction of the world is multipolar due to joining initiatives by world wealthiest economies countries.

Apart from this, collective climate resilience efforts also created vacuum for multipolarity to be filled with. Twenty-first

Century's requires problems are multipolar in nature and hence requires solutions accordingly. For instance, climate change and global warming require collective measures to mitigate its repercussions. As a result of this, Conference of Parties by UN member states on climate-change is case in point which demonstrates increasing multipolarity.
