down the basic principles upon which the constitution of Pakistan was to be framed.

These are three constitutions in the history of Pakistan and all these constitutions have one thing in common, that is the Objective resolution.

Principles of Objective Resolution: Foundation of Constitution Making

Objective resolution is the foundational basis of constitution and no entity can override it. Following are the principles of objective resolution that serves as the foundational basis.

1) Sovereignty:

3) Islamic way of life:

The document states that Muslims should be allowed to practice their religion and live their lives according to the teachings of Quran and Sunnah.

4) Unity of diverse groups:

Interests and lives of the minorities shall be protected. Non Muslims should be independent to practice their religion.

5) Establishment of Islamic Principles:

Principles of democracy, freedom, equality, tolerance and social justice shall be exercised.

These basic principles are the part of every constitution they cannot be removed or violated. Rather the constitutions are derived from it.

Ideological boundaries of Pakistan are derived from the Pakistan's ideology that is the Muslims need a separate state to practice their religion freely and live freely.

This ideology of Pakistan is legally and constitutionally ensured by the document as Objective Resolution.

Objective Resolution: A First Step Towards the Islamization of the State.

Objective resolution is the document that declares the state of Pakistan as a Islamic state. Constitution and law making is to be within the boundaries of Islam. This progress defines the ideological boundaries of the state of Pakistan.

1) Religion of State:

Islam will be the religion of the state with sovereignty lying with Allah Almighty. Only a muslim can be the Head of state of Islamic country.

2) Sources of Law:

Quran and Sunnah are considered as the only sources of law. No law can be formulated that violates the Quran and Sunnah.

3) Protection of Cultural Identity:

Pakistan came into being on the basis of religion. Its cultural identity needs to be preserved and protected. This is only possible if Pakistan is an Islamic state.

4) Islamic Democracy:

Islamic democracy shall be practiced in the state of Pakistan. All citizens are equal in the eye of law without any discrimination.

These ideological boundaries are provided by the objective resolution. In dealing

with the other states of the world these ideologies are not compromised.

However, the ideological boundaries shall not be rigid. They should be made flexible with the fast moving changing world. Principles of Islam should be incorporated with changing dynamics of the world. Rigidity might hinder the country's progress. After the death of the prophet (SAW), Caliphs, also expanded the ideological boundaries that were set previously.
