## 4.4. Disorganization Theory

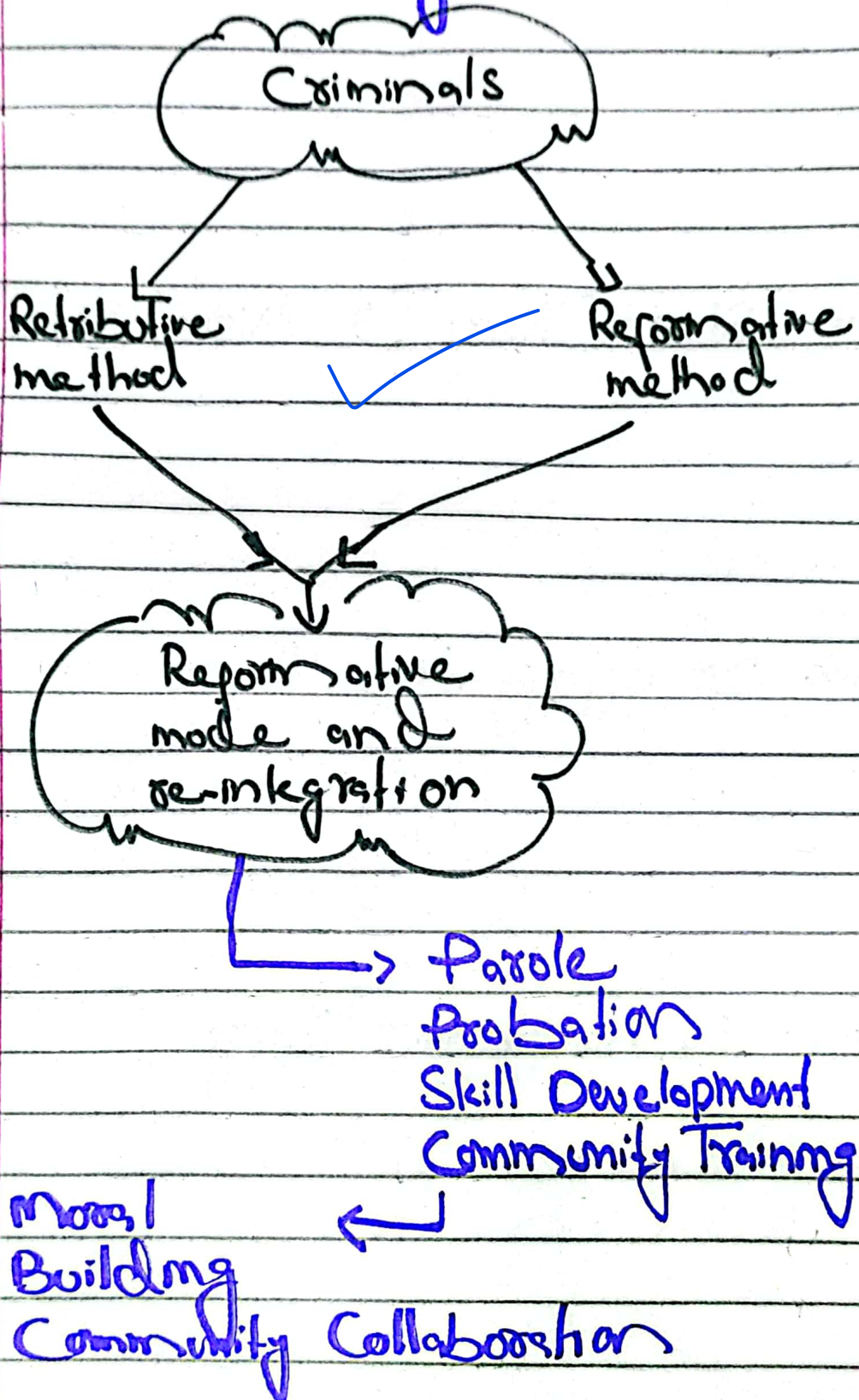
The ethnic heterogeneity, excessive mobility and poverty leads a criminal towards recidivism.
