Scientist "Alfred Wegner" gave the theory to the world tectonics drift theory.

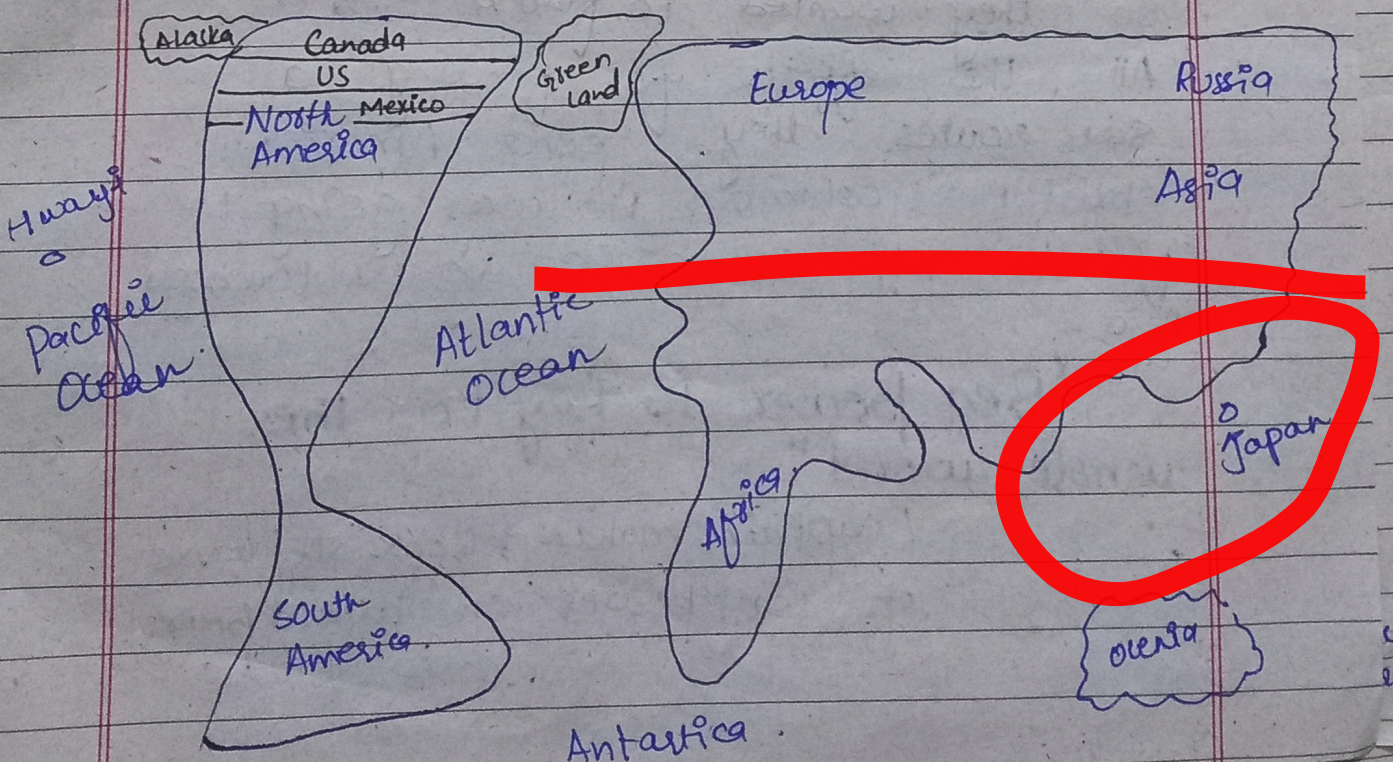
According to this theory this world is divided into several continents.

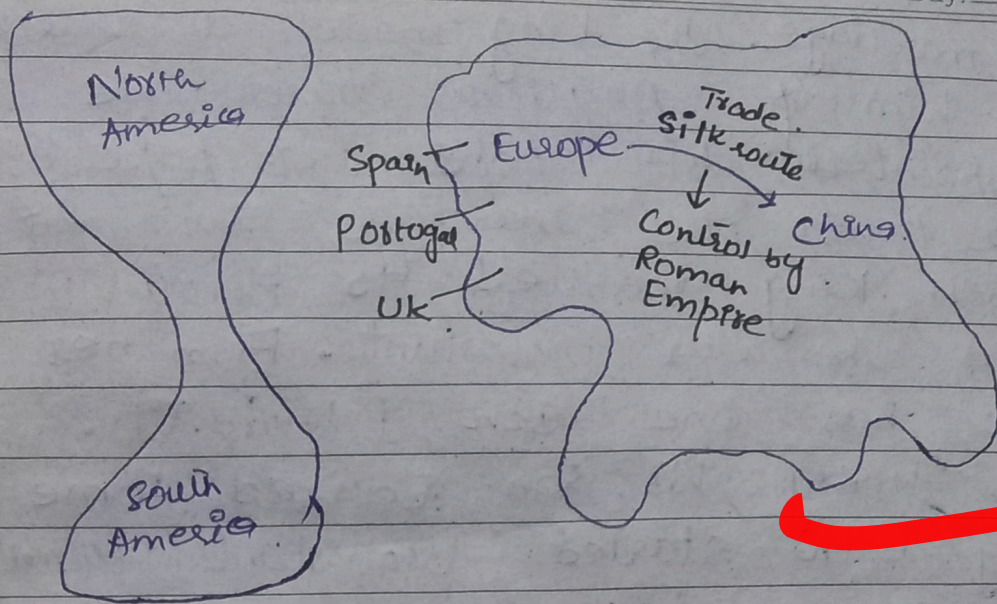
Following are the reasons of colonization of America.

King Henry VIII thought that only men has a right to rule the world. He married to Spanish Queen Catherine. From Catherine, he has only one daughter Mary-I. He wanted to annul his marriage. At that time annul decision made by pope in Roman Catholic church and the pope didnot agree to dismiss

the marriage, the king made a church by himself Anglican Church. He appointed his pope and pope declared the marriage annulment. Then king married to Henry VIII and she was protestant. From her he has one son Edward VI.

After Henry his son Edward come they both started protestant reformation. After Edward Mary I came she was Catholic. She reversed the whole process of protestant reformation. She burned 300+ people (protestant) alive. That is why she is being called bloody mary. Then Elizabeth I came she was ^{protestant} ~~Catholic~~ and killed ~~Catholic~~ ^{protestant} people. At that time, people were humiliated. This became one of the major reason to leave the homeland and settled in new world.

POLITICAL PERSECUTION :

 no land for disposal.

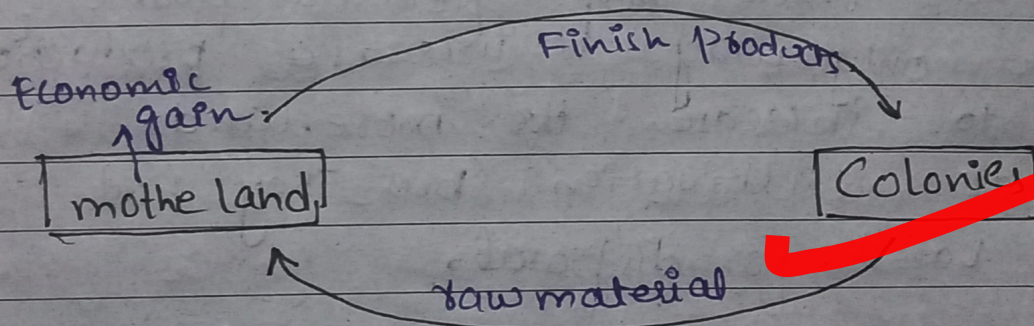
POOR AGRICULTURE

Rousseau:

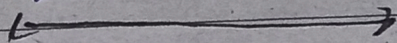
Rousseau told the people that
