Climate change refers to long-term shifts in temperatures and weather patterns.

Such shifts can be natural, due to changes in the sun's activity or large volcanic eruptions. But since the 1800s, human activities have been the main driver of climate change, primarily due to the burning of fossil fuels like coal, oil and gas. Burning of fossil fuels generates greenhouse gas emissions that act like a blanket wrapped around the Earth, trapping the sun's heat and raising temperatures.

The main greenhouse gases that are causing climate change include carbon dioxide and methane. These come from using gasoline for driving a car or coal for heating a building, for example. Clearing land and cutting down forests can also release carbon dioxide. Agriculture, oil and gas operations are major sources of methane emissions. Energy industry, transport, buildings, agriculture & land use are among the main sectors causing greenhouse gases. Climate scientists have showed that humans are responsible for virtually all global heating over the last 200 years. Human activities like the ones mentioned above are causing greenhouse gases that are warming the world faster than at anytime in at least the last two thousand years.

The average temperature of the Earth's

surface is now about 1.1°C warmer than it was in the late 1800s, (before the industrial revolution) and warmer than at any time in the last 100,000 years. The last decade (2011-2020) was the warmest on record, and each of the last four decades has been warmer than any previous decade since 1850. There is an urgency to deal with the climate cause. Despite its urgency climate crisis remains the most neglected cause. (265)

Majority of the world population lack awareness about climate change. Lack of awareness contributes to the negligence of climate crisis. If people will not know about the serious threat, they will not be able to contribute in controlling climate cause. During a research held on the awareness of climate change, **55%** of the people thought there were more urgent priorities to be worried about climate change. **21%** said that they did not know much about climate change. Over half of adults who were not worried about climate change think there are other more urgent priorities to be worried about. Worries about climate change, Great Britain September to October 202. **Office for National Statistics.** Therefore, when a large number of population is not worried about the climate

change it will play role in the negligence

Hence, people's misconception about the climate change played a major role in its negligence.

Climate cause has been neglected due to the short-term economic interest. Countries heavily reliant on fossil fuels for their energy production and export; such as oil-producing nations, may prioritize short-term economic gains from the fossil fuel industry over long-term environmental concerns. Some countries may prioritize

rapid economic growth and industrialization, which can lead to increased greenhouse gas emissions. They might be reluctant to implement climate-friendly policies that could slow down economic development. Examples of countries that play a role in neglecting climate change due to short-term economic interests include the **United States** during periods of increased fossil fuel production,

Brazil's deforestation policies, and **Australia's reliance** on coal exports.

Therefore, short-term economic interest may lead to the negligence of climate change. (122)

Disregard for international agreements has played a more crucial role in neglecting the threats of climate change. Some countries of the world take international agreements lightly, some exit from the agreements while some of the remaining countries have fulfilled the conditions and targets of the agreements.

United States under Trump pulled out from **Paris Agreement**. His stance was that if China, India and other countries do not cut required carbon cuts then why United States do that? After the COP-27 in the first five years majority of the countries did not even stated initiative, developed and the developing world. **Reference: UNFCCC. COP-27**. Hence disregarding attitudes of countries

towards international agreements contribute in the negligence of climate change. (117)

The lack of policy action on climate change can contribute to negligence in addressing this global issue, allowing greenhouse gas emissions to continue unchecked. This will ^{it will be} cause ^{increase in} harmful the earth's temperature. There are lots of example where countries have lack of policy action against climate change. During the Trump administration (2017-2021), there was a notable lack of policy action on climate change, and the United States withdrew from the Paris Agreement in 2020. This withdrawal signaled a reduced commitment to addressing climate change at the federal level.

According to the World Bank Report, Between June and August 2022, torrential rains and a combination of riverine, urban, and flash flooding led to an unprecedented disaster in Pakistan. According to NDMA, around 33 million people have affected by floods, including nearly 8 million displaced, 1700 people died from which one-third of children.

These conditions are leading to wildfires.

Higher temperatures and increased dryness are thought to be leading causes of increased burned areas, the extent to which burned area changes are due to natural variability or human-caused climate change has remained largely

unresolved. Record-breaking forest fires during California's summer months have become a regular occurrence. Environmental observations indicate that summer burned areas in northern and central California have increased fivefold during 1996 to 2021 compared to 1971 to 1995. Further, 10 of largest California wildfires have occurred in the last 20 years - five of which occurred in 2022 alone.
