According to the education statistics 2016-17, 86% of Pakistan's Primary schools are based in rural parts with limited access to the internet and mobile connectivity restricting access to any digital learning solution. A Unicef Report indicates that

during the Covid situation in 2020 under tele-school programme initiated by the Ministry of Federal Education and Professional Training (MOFEPT),

peoples had less resources to online study. The report indicates that 75% of the countries have used educational TV for at-home learning, while 57% of the countries have used Radio for online education. This indicates a substantial and global divide that will pose a barrier to the digitisation of education. (142)

their study choices. The online learning experience presents new challenge for the students. For taking online classes, students need to be attentive. They lack social interaction with their peers and teachers. Because of less environment exposure they are unable to polish their communication skills.
