The year of pandemic and lockdowns were example par excellence that online education is pragmatic and workable. However, it is imperative to note that there can be resistance to such a radical change and some hindrances that can arguably impede the process. Hence, it is important to address

In shifting to online education, the term convenience not only refers to ease and comfort but it is also proportional to the reach of education. Since ages, the educationalists and policymakers have struggled to ~~increase~~ make educational accessible to public at large. The issue of access to education is even more prominent in developing countries like Pakistan, particularly in less developed provinces, where poor infrastructure of roads and educational institutes deter many from gaining education. In a province where 65% roads are in poor condition as per world bank, it is difficult for students to conveniently commute to traditional classrooms. However, shifting to online education will make it convenient for students from less developed areas to attain

However, ~~conv~~ traditional classroom is not only inconvenient for people from ~~had~~ less privileged areas and background but also for those who have an easy access to classroom.


One problem which has plagued the classrooms of both the ~~more~~ most developed of nations and developing nations is the issue of bullying and harassment, which create toxic ~~environ~~ environment for students in traditional classrooms. Even the brightest of students.

online classrooms, as opposed to traditional, can offer a safe and healthy environment that is indispensable part of education

Another aspect of healthy environment is "inclusiveness". This means that online

classroom are far more inclusive than traditional classrooms. Persons with disabilities can feel more encouraged to get education. The problem is even more prevalent in less developed and conservative societies. For example in Balochistan, Pakistan, the 70% girls are out of school as compared to 30% boys. The problem can also be attributed to the lack of segregated schools for girls but setting up separate schools for boys and girls require for more funding and maintenance cost. Online education offers simple solution to such a grave problem. The girls (or women) can attend classes online and even in segregation as there is no restriction of the number of classrooms. Thereby, it resolves the problem of gender discrimination in education that is pre-eminent in conservative areas of a society and makes the system of education more effective.

Another reason that makes traditional classroom instruction ineffective is the decaying "quality" of instruction. As education is expanding, it is becoming increasingly difficult to ensure its quality, especially in government funded public education. This can be attributed to the difficulty in monitoring the classrooms. The problem is apparent in developing countries, and Pakistan serves as a good example.

The "learning poverty" - which the World Bank defines as being unable to read a simple sentence by age 10 - is sweeping across classrooms of Pakistan. As World Bank reports that 4 out of 5

children in ^{Developing} countries are unable to read a simple sentence by age 10. This means, that ~~not even~~ even school going children are suffering from "learning poverty". The underlying reason is the poor quality of education which can only be improved by monitoring classrooms, which is virtually impossible for all traditional classrooms. However, it is far more pragmatic in the case of online education where ~~the~~ an authority could be set up to monitor the classrooms. Multiple classrooms can go through "quality check" simultaneously. Lastly, lessons can be learned from COVID-19 that a ~~the~~ calamity can befall on a society at any level i.e. global, regional, local and individual level. Such calamities like COVID-19 or natural disasters like floods, earthquakes etc ~~and~~ can interrupt the ~~traditional~~ traditional classroom but not an online class. The recent outbreak of the so-called "pink-eye" infection not only led to closure of many schools but also compromised the health of many students. Such interruptions in traditional classroom could also be caused by riots and conflicts which can lead to closure of educational institutes. Conversely no such problem can afflict the flow of education in an online classroom. The shift to online ~~at~~ education during COVID-19 lockdowns is a reasonable example.

However, regardless of how effective and convenient online education seem, as opposed to traditional classroom, it is apt to consider some possible counter arguments. For example, instead of increasing its accessibility, online education might actually make education even more exclusive ~~to it~~ by restricting its access to those who are privileged enough to own a medium, such as laptop and internet. Thus, the disparity might remain as developed areas have access to internet and affordability of laptop varies from person to person. This might increase disparity in education and lower its reach further.

Similarly, the ~~bullying~~ bullying and harassment might continue in its modern form i.e. "cyber bullying". This could prove even more devastating for victim than physical bullying, which ~~is~~ remains restricted to classroom, as this might even continue to haunt them in their homes too. The moments of salvation, which the victims enjoyed at their homes could also be stolen from them. The harassment could spread from the online classrooms to the social media of the victim, and the harassers could be even more encouraged to harass as ~~they~~ their location would be possibly unknown or hundreds of miles away from victim, compelling them to

harass without any fear.

The segregation and exclusive ~~environment~~ environment in the name of "inclusiveness" might prevent students from the exposure, interaction and socialization, which are an inherent part of education in a traditional classroom. Students, particularly young ones, need physical interaction to make friends. Such opportunities will be absent in exclusive and virtual environment the online education promises. Similarly, those persons with disabilities might never learn to cope with them in the actual world as such training is often takes place when they learn and grow with their peers from young age.

As far as the quality is concerned, it can deteriorate even further.

This could be due to two reasons, which are attributable to online education. Firstly, it could become easier to cheat the exams aimed at assessing/evaluating the performance of students and secondly by making it difficult for teachers to ensure the attentiveness and presence of pupil attending his or her class. Hence, the quality might ~~be~~ worse, making online education ineffective as compared to the traditional classroom where teachers and instructors can ensure the presence and attentiveness of students.

Lastly, one might argue that online education is ~~not~~ not only ~~more~~ vulnerable to more interruptions but also more frequent interruptions. ~~This would require~~ Online education would require a stable and reasonably fast internet connection. Students with unstable connections could face constant interruptions, putting them at ~~an~~ ^a disadvantage.

Also, a malware attack, or in other words, a malicious software virus can attack the online system of the educational institute and ~~not~~ not only interrupt the education but also breach the ~~data~~ data of the institution.

Such concerns might feel ~~to~~ reasonable prima facie, but on deeper inspection they ~~are~~ can be ~~sure~~ out as largely exaggerated.
