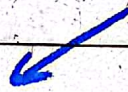

9) Rejection of 'No-Confidence' vote

In 2022, rejection of 'No-Confidence' vote led to political chaos. Opposition presented 'Vote of No-Confidence' against premier, Imran Khan.

Hence, rejection of 'No-Confidence' vote



was announced.

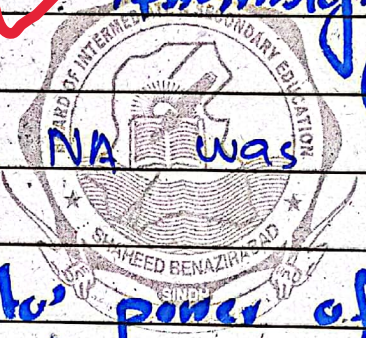
b) Dissolution of the National Assembly

Further, the National Assembly was dissolved. President on the advise of PM dissolved the NA.

'According to Article 58, President, Arif Alvi dissolved the National Assembly.'

Thus, the NA was dissolved.



c) 'Suo Moto' power of Chief Justice

Furthermore, CJ of Pakistan took 'Suo Moto' on 'Vote of No-Confidence'. Opposition went to get support of the Supreme Court.

"At midnight, the CJ, Umar Atiq Bandayk declared rejection of



'No-Confidence' vote unconstitutional.

Hence, Chief Justice took 'Quo Moto' on political conflict.

d) Successful passing of 'No-Confidence' vote

Moreover, "No-Confidence" vote was successfully passed. The National Assembly was called again.

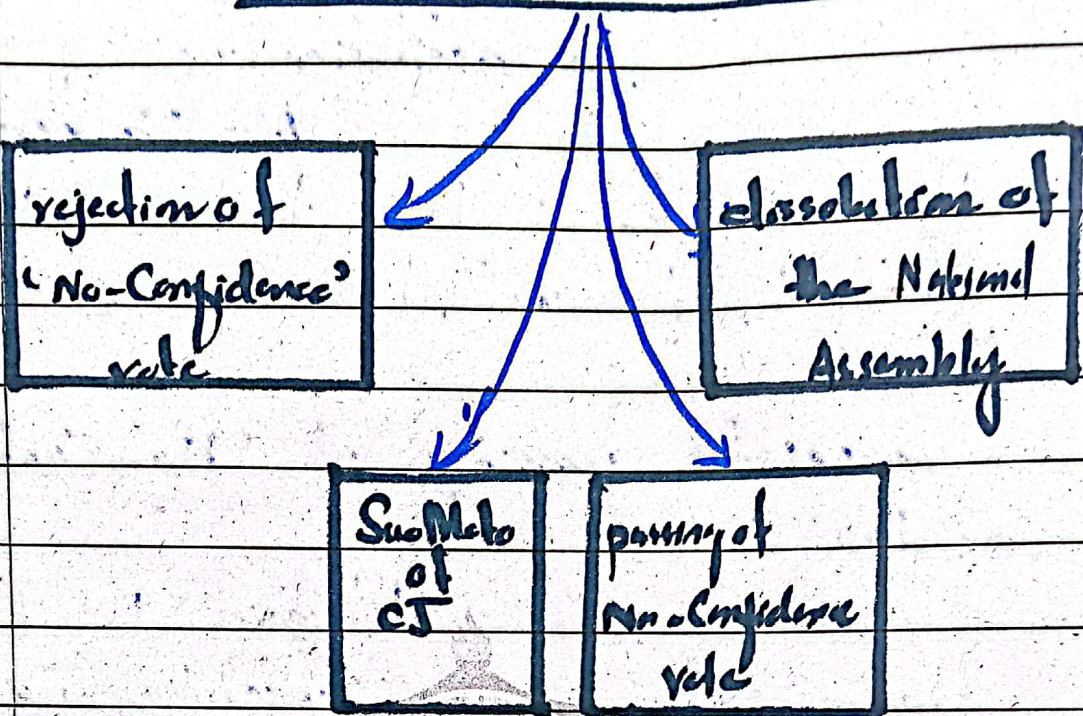
"Vote of 'No-Confidence' was passed at 174/242 against premier, Imran Khan."

4- Poor political governance led to constitutional crisis

Following are evidences of it:

a). Delay election process

Political instability led to delay election process. After failure of Imran Khan's rule, Punjab and KPK elections got delay.

Thus, poor politics became a cause
of delay elections.

b, An unbroken relations between
civil - military

An unbroken civil-
military relations also led to con-
stitutional crisis. On 9 May incident,
cases of civilians were held und-
er military courts.

Army Act of 1952,
civilians trials were

be held under
military courts."

Hence, poor politics led to establishment of military courts.

c) Attempt to curtail power of the Supreme Court

Moreover, attempt to curtail power of the SC also led to constitutional crisis. The next government presented a bill to curtail the SC-powers.

"President Arif Alvi rejected the bill on the view of Article 75(1) to maintain the SC-powers, according to Article 199."
