a. Direct Violence:

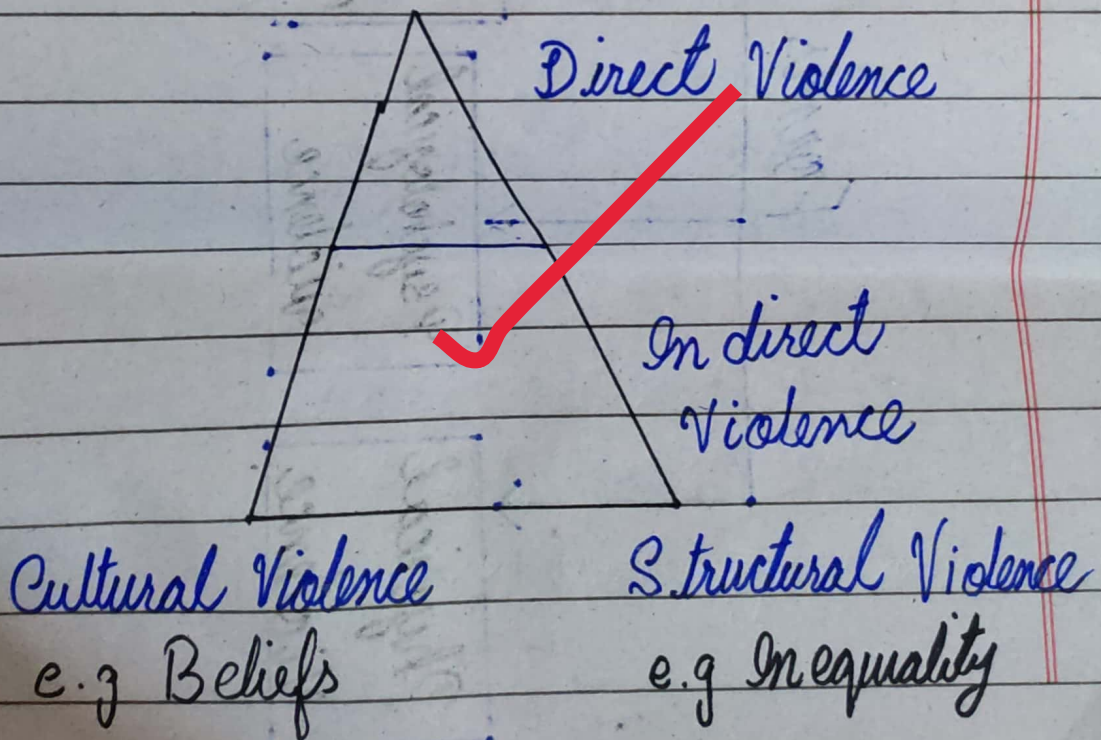

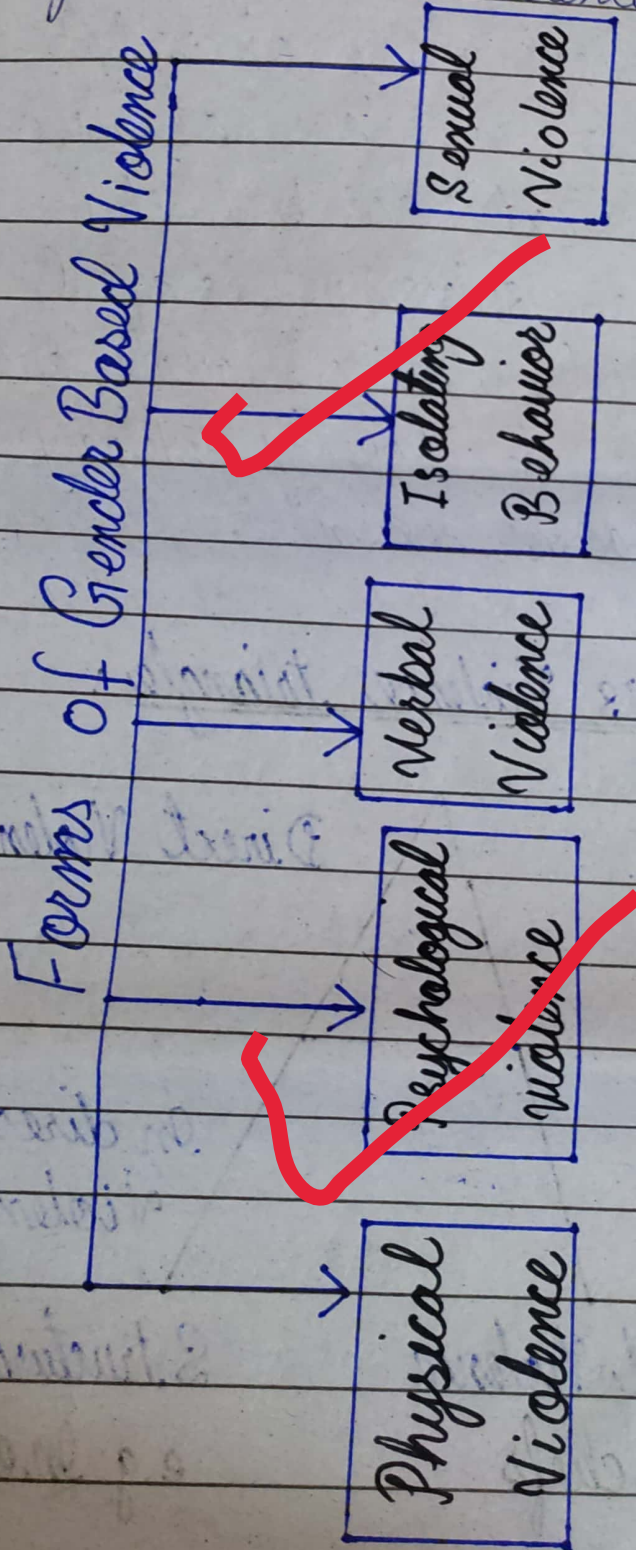
3. Galtung's Violence triangle :

32 pc of women have experienced physical violence in Pakistan
