2- The Senate of the USA: Composition

Senate of the USA is a lesser membership of representatives. It is composed of less numbers as compared to the lower House.

Senate has 100 members with two-party system of 52 and 48 members.

Thus, the Senate is a transparent framework of the USA.

3- The Senate of the USA is the most powerful house in the world.

The Senate is the most powerful as below:

a) Real executive powers of the senate
Senate is a real executive of the USA. In fact, all foreign affairs depend on the approval of the Senate.

League of the Nations came in the power of

Treaty of Versailles that was proposed by Woodrow Wilson but not approved by the Senate and so failed.

Thus, Senate is the most powerful executive authority.

b) least membership and long tenure of Senate

The USA Senate is least membership and long tenure house. However, India and Pakistan's Upper House has the same tenure as the lower House.

Senate of the USA is composed of 100 members as compared to the lower House of 435, while its tenure is 6 years as compared to the lower House of 2 years.

Hence, Senate has long tenure with least membership.

c) Equal legislature and money power of Senate

Senate is only the powerful house in the world with respect to full legislative authority. However, Pakistan and India's Upper House has no authority over budget bill.

Senate has full authority over budget as well.

Therefore, Senate is full legislative body in the world.

d) Senate members of the USA are elected directly

Moreover, Senate members are directly elected. While

India and Pakistan's Upper House members are indirectly elected.

Thus, Senate members are directly elected.

e) Senate is a real representative body of Congress

Further, Senate is a real representative body of Congress. However, Pakistan and India's Upper House is not a real representative body of Parliament.

Hence, Senate is a real representative body.

f) The highest court for impeachment of Senate

Furthermore, Senate is the highest court of impeachment to impeach the President and the SC-judges. However, Upper House of India and Pakistan lacks such authority.

Senate has power to impeach the president and judges on the charges of corruption.

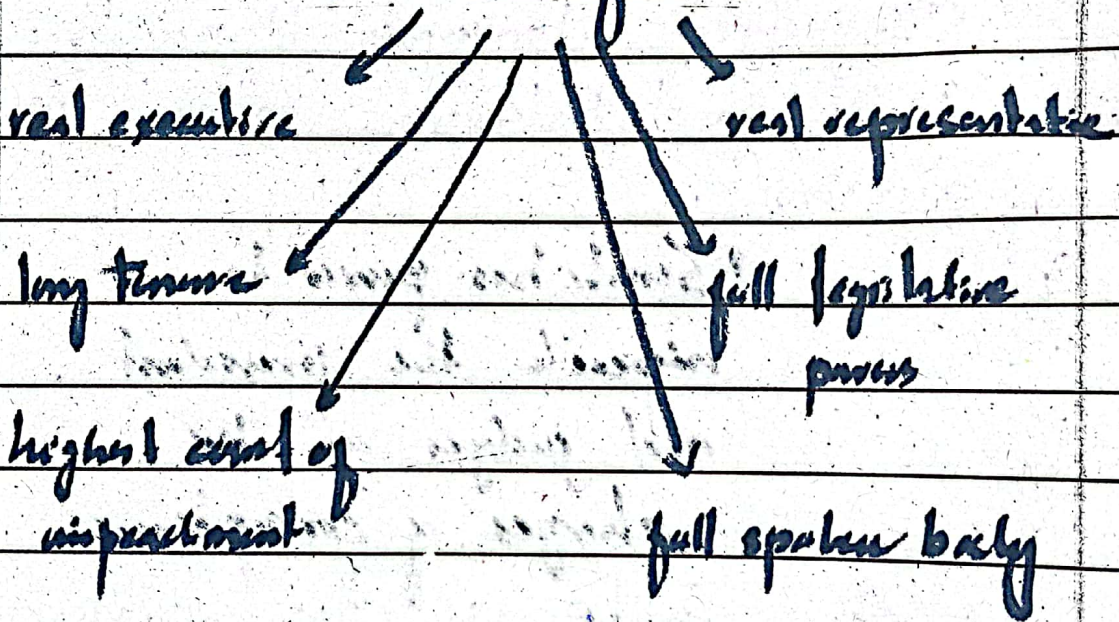
Hence, Senate is the highest court of impeachment.
