Criminal law is a legal document of dealing crimes. In fact, criminal law has its elements to deal crimes. Therefore, criminal law is a legal action against crimes.

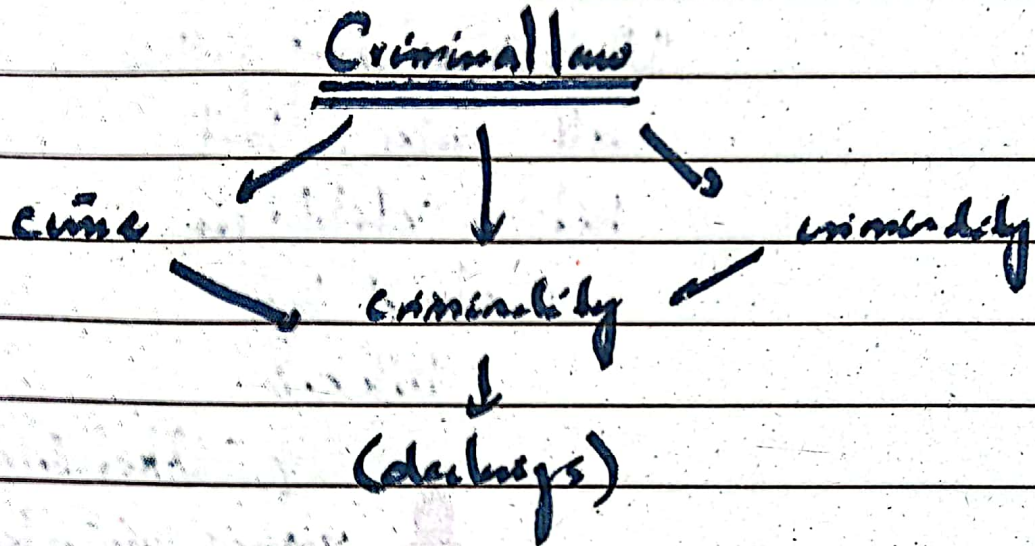
2. Definition of 'Criminal Law'

liability.

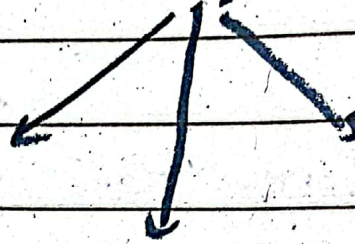
• murder, rape, assault,
