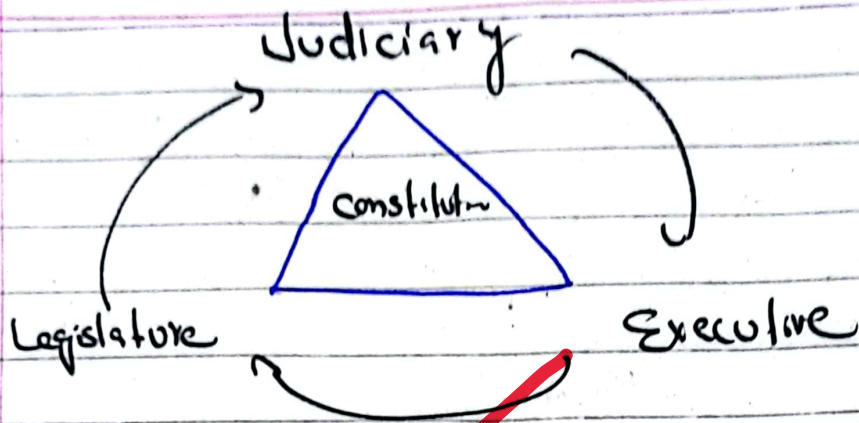
### ① Introduction

### ② History of Constitutional crisis: An overview

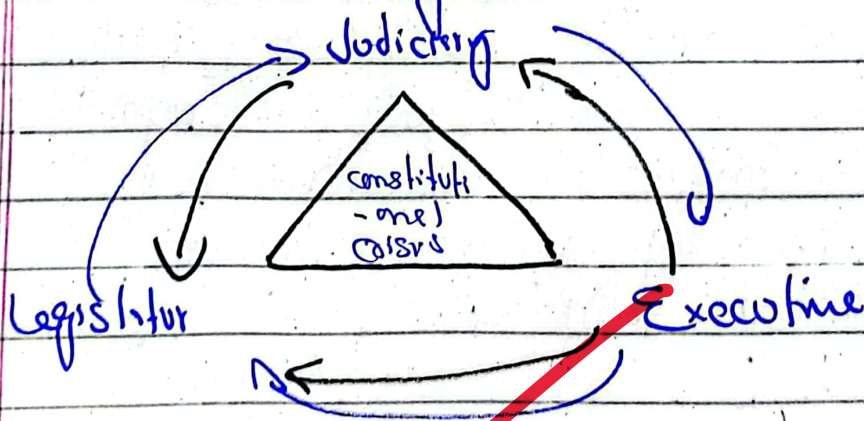

#### (ii) Politicisation of Judiciary

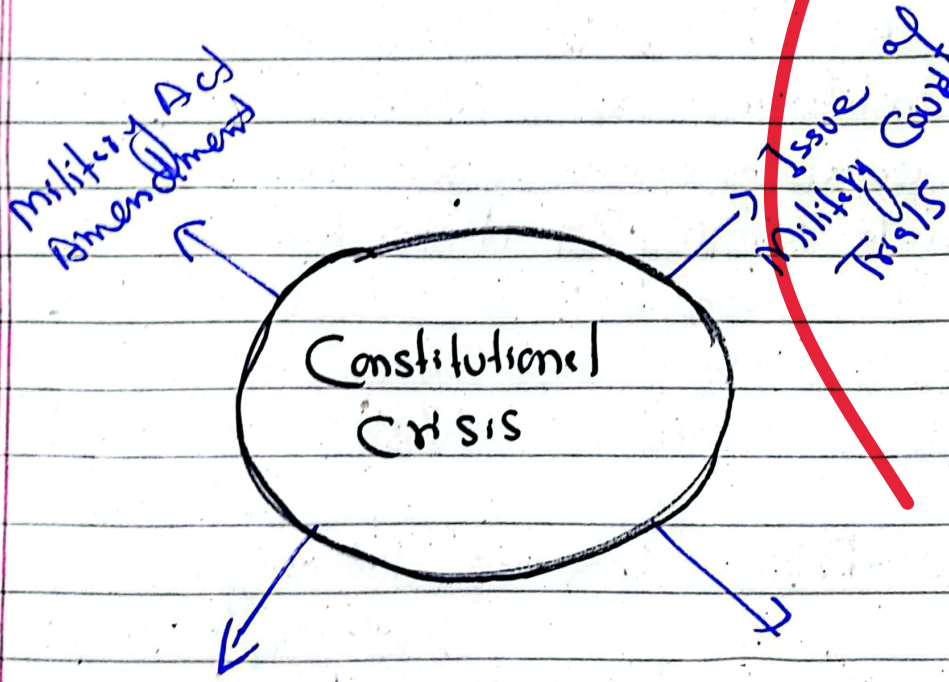

(i) Inability of to abide by -the constitutional law owing to their political rivalry

As this can be seen through the following example: After the Horse Riding of the Ex- P.M in 2002, the street politics took the reins of the political system. That created more constitutional issues. Similarly according to the book, How Democracy Dies, it is mentioned that Political Polarization will ultimately create the constitutional issues and eventually the failure of democracy.

(ii) Legislature's failure to form an active committee to vet the executive policies in the Parliamentary

form of government (that Pakistan has) the legislature can form the committee to overlook the actions of the Chief Executive in order to ensure the constitutional balance. However, in Pakistan's political governance this has been lacking. As that can be seen through the visit of Ex P.M to Russia at a critical time.
