Before the adoption of the draft phino. constitution on the report of basic Principles march 1954 repulling in an overwhelming victory for the united front (Jagustont), an alliance of parties opposed to the ruling CN mustim League. The defeat of the muslim league in East 0 Bengal which had 56 percent at the total Population of Pakiston, led to demande for the resignation of the central government and dissolution of constituent assembly as unrepresentative.
