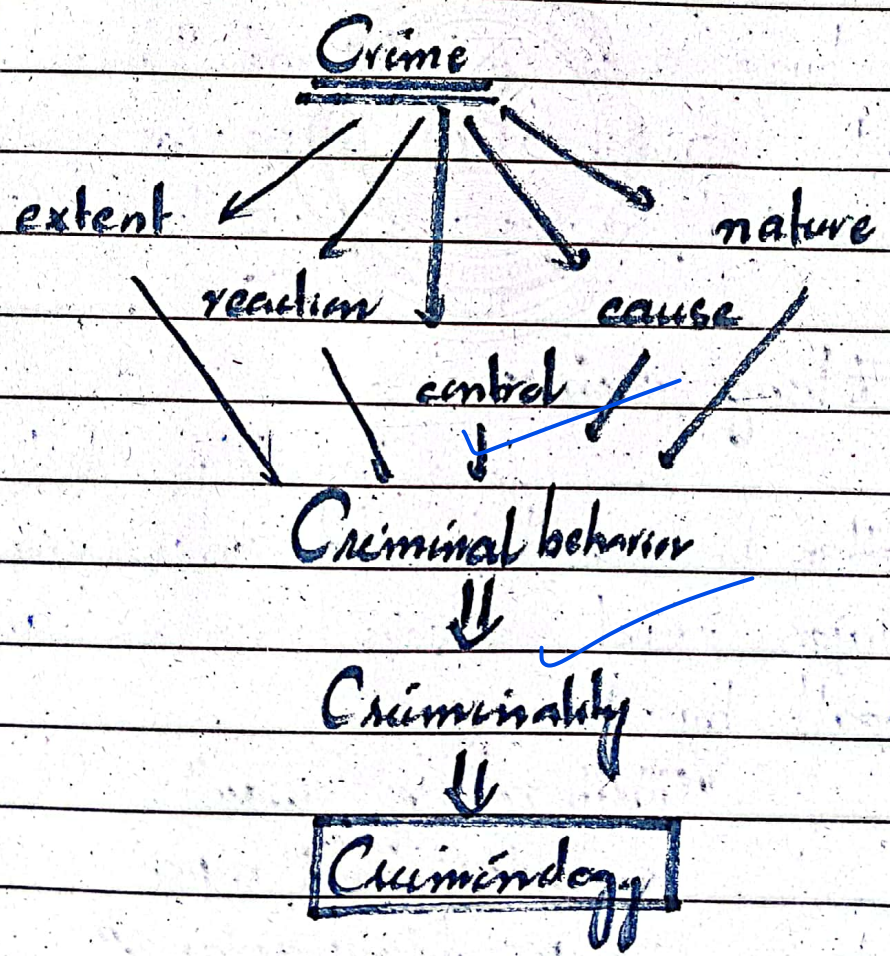

Moreover, Criminology also helps in solving misdemeanor crimes. Not only major crimes like felony, but minor also dealt by criminal law.

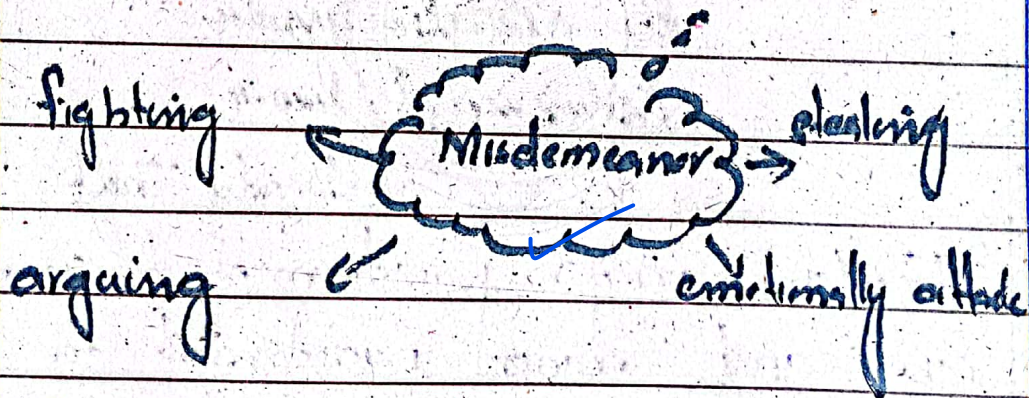
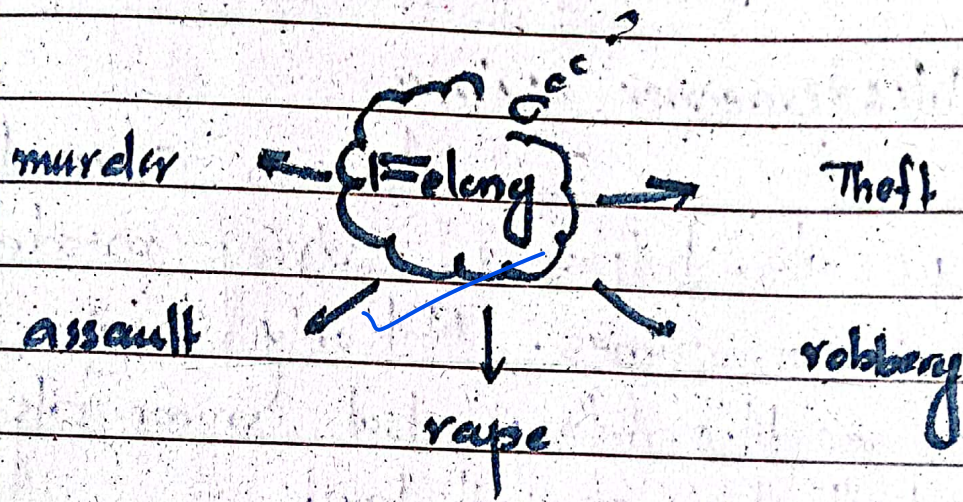
"stealing, fighting, emotionally invasive etc are also under influence of law."

b) Scope of criminology in forensic

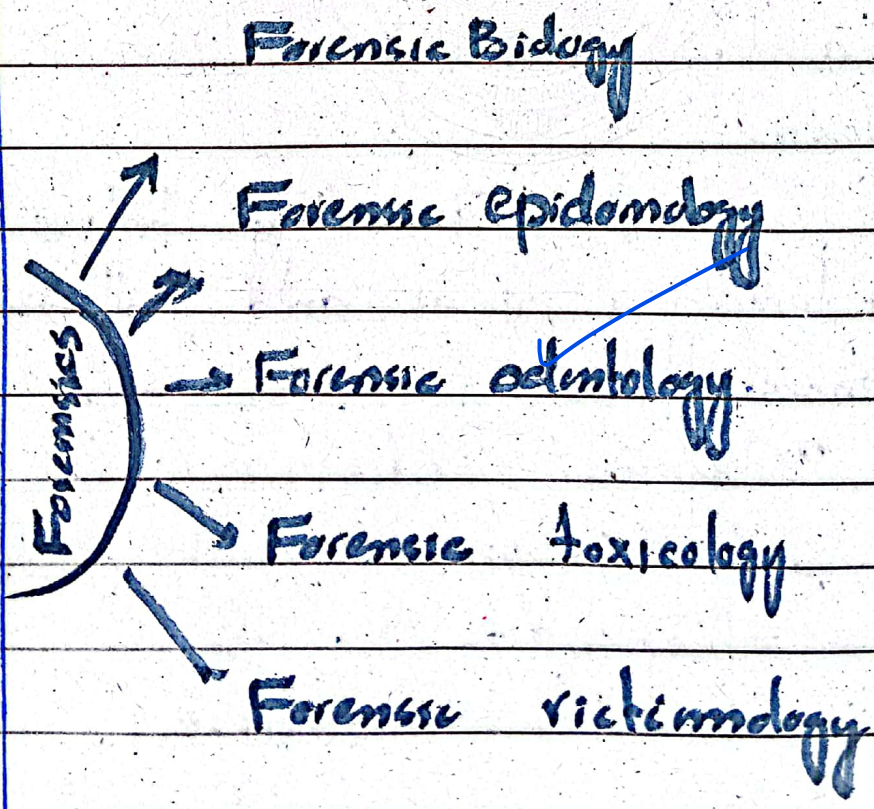
