"Public governance are actions performed by the government."

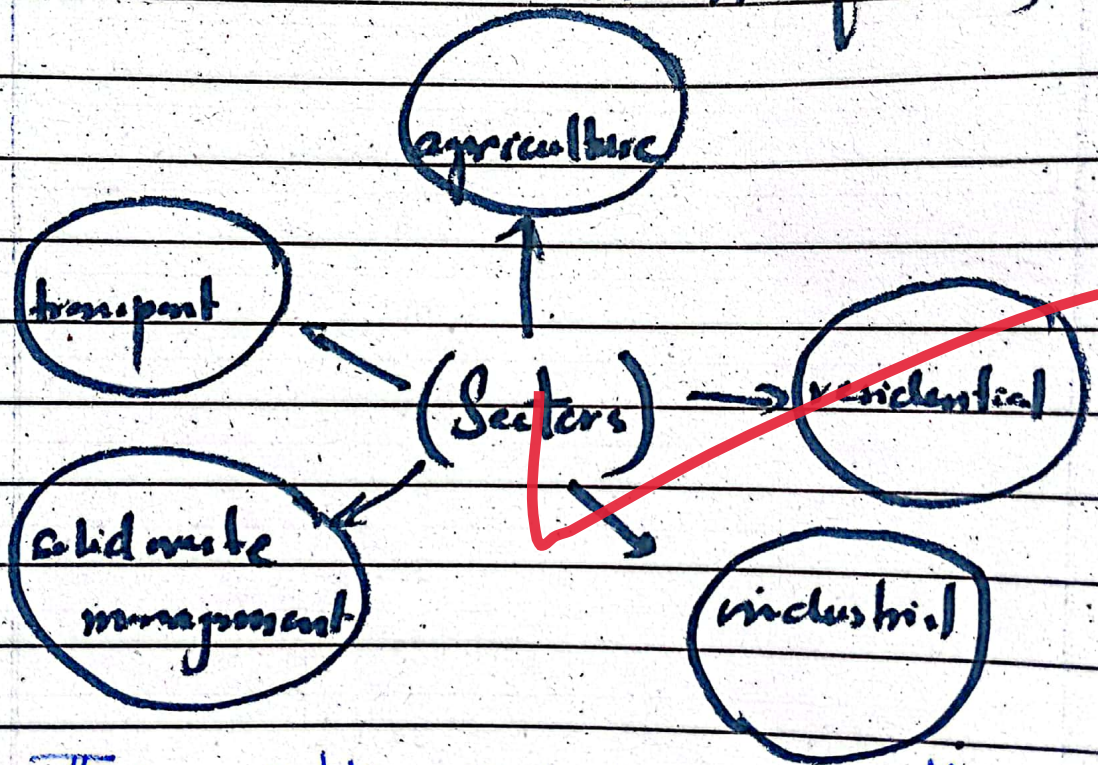

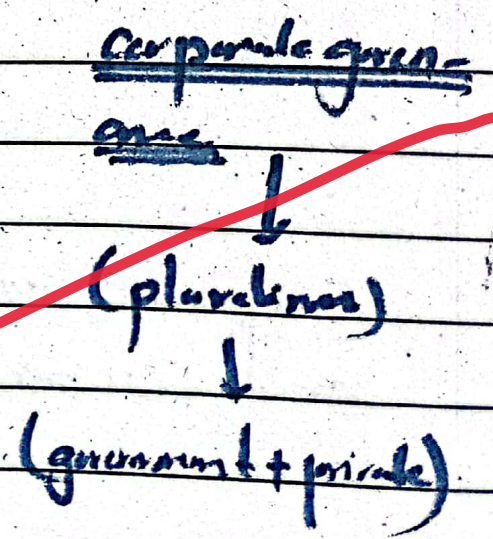
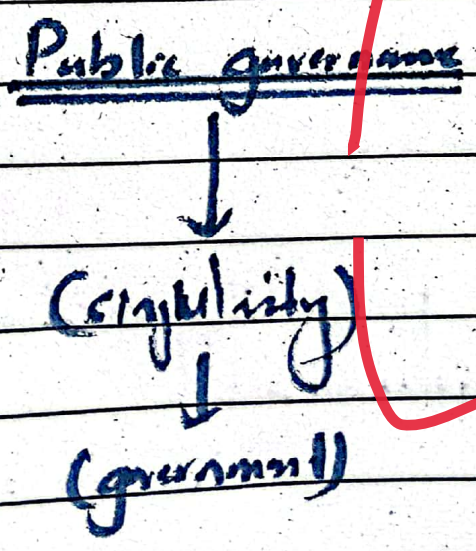
Difference between public governance and corporate governance
