This huge population can become an asset for Pakistan if they can use their academic skills and knowledge to create innovative solutions for various challenges in the society and economy of the country. At the same time, youth bulge can become a liability for a country if they are not provided with adequate opportunities and resources to develop their potential and contribute to the society and the economy. Youth may create problems such as youth violence, youth unemployment, youth dependency, etc. If such problems occur then it will be a liability than an asset.

If we talk about the good will of the country isn't dependent on youth. There are other more prominent factors to promote good will such as

foreign policy and economic prowess. Developed countries like Switzerland, Canada, New-Zealand, etc have no youth bulge to promote their good will in the world.

One of the most developed countries in the world is Japan, its total youth population is 12% of its total population, so it is wrong to say youth is promoter of good will. Furthermore, unskilled, uneducated, inexperienced youth is a liability for any country. All western

countries are not willing to accept the 9 emigrants from countries like Syria, Iraq, Libya and African states, because they have no knowledge and skills to contribute in other country's development. According to the guardian The E.U member states ordered the deportation of 96,550 emigrants. This example show that youth bulge can be a liability.

As far as economic recovery is concerned, there are multiple other things which are the root causes of economic downfall which must be fixed at 1st priority. Corruption, poor law and order situation and no proper mechanism of governance must be fixed for economic recovery. China is a great example in this regard, China does not require remittance from overseas Chinese to build-up their economy, they implemented laws and tightened the regulations to make their country economically stable. Chinese example is valid example to prove that youth bulge has least contribution in country's economic recovery.

— Pakistan if we analyze the skill development, lacks skill development and employment. There is neither vocational institutes nor state of the art educational

System to compete with the youth of developed world. In developed countries they teach skills to their youth at primary level. Education system of western countries are specifically designed to promote skills and make them identify their area of interest. According to the World Economic Forum report, countries like Singapore, China, Japan, Estonia, Canada, Singapore and Finland teach skills to their youth at school level. Pakistani youth cannot compete with their youth due to outdated educational mechanism.

Hence, advancement in science and technology is also dependent upon the performance of universities. Pakistani universities doesn't give proper attention to research. There are many universities in Pakistan who don't have thesis as a compulsory subject to get the degree. Science and technology requires proper attention from university teachers and scholars. Youth bulge only cannot promote research in science and technology. These are all examples to substantiate that youth bulge is a liability not an asset.

If we take example of Olympic games, it is considered as a mega event of youth representation. Countries with strong foreign policies and economies, Canada, New-Zealand, Singapore, etc. try hard to prepare their youth for this mega event. One of the most strong countries in terms of foreign policies and economy is USA, USA sent highest number of athletes (613) in Tokyo Olympics 2021 (Olympics.com). If we look at the foreign policies, youth can also frame foreign policies. There are multiple countries having youth as a foreign minister. Pakistan had two youth foreign ministers, Hina Rabani Khar assumed this role in 2011 at the age of 33, Bilawal Bhutto Zardari became the foreign minister at the age of 33 in 2022. In that case youth can become an asset if they become the framers of foreign policy.

Youth against corruption is network of young activists from different countries who work to promote transparency and accountability in the world. Young Anti-led Corruption Network (YACNI) is coalition of young individuals in Nigeria who collaborate to fight against corruption and promote good governance in their country. These examples show that youth is not a liability and it is a potential asset against all forms of evil including corruption.

Now let's talk about skill development, Pakistan does not lack skills and there are multiple skills development and vocational training centres for men and women. Institutes like National Vocational and Training Centre, Sindh Technical and

vocational institute, Aman Foundation by 14
Sindh government, etc. they all provide
various courses and programs to help
youth to acquire marketable skills and
enhance their employability. In educational
Sector of Pakistan, government has taken
steps to revamp the educational system
and promote skills at primary level. For
that matter, Single National Curriculum is
one step towards uniform educational sys-
tem, In addition president Arif Alvi's initiative
to promote and improve mental health in
school is a national program that aims
to enhance the socio-emotional development
of school-going children. It is evident
from these examples that Pakistan
is going towards the right direction
for making youth as an asset and not
a liability.

As far as research in science
and technology is concerned, Pakistan
is not behind in this field as well. There're
multiple universities in Pakistan famous
for promoting research. Universities
such as Quaid-e-Azam university Islam-
abad, placed in 401-500 rank-band

globally. It has the strong reputation for research excellence and innovation specially in Physics, biology and environmental sciences. Government college University Faisalabad, is ranked 501-600 globally, has vibrant research culture and has established several institutes for research in Physics, Microbiology and Food Sciences. University of Management Technology Lahore, COMSATS University Islamabad have also vibrant reputation due to their research programs (Times higher education.com) So, its wrong to say, there is lack of focus towards research. Pakistan has all avenues available to provide them quality education at university, focusing towards quality research for promoting science and technology in the country.
