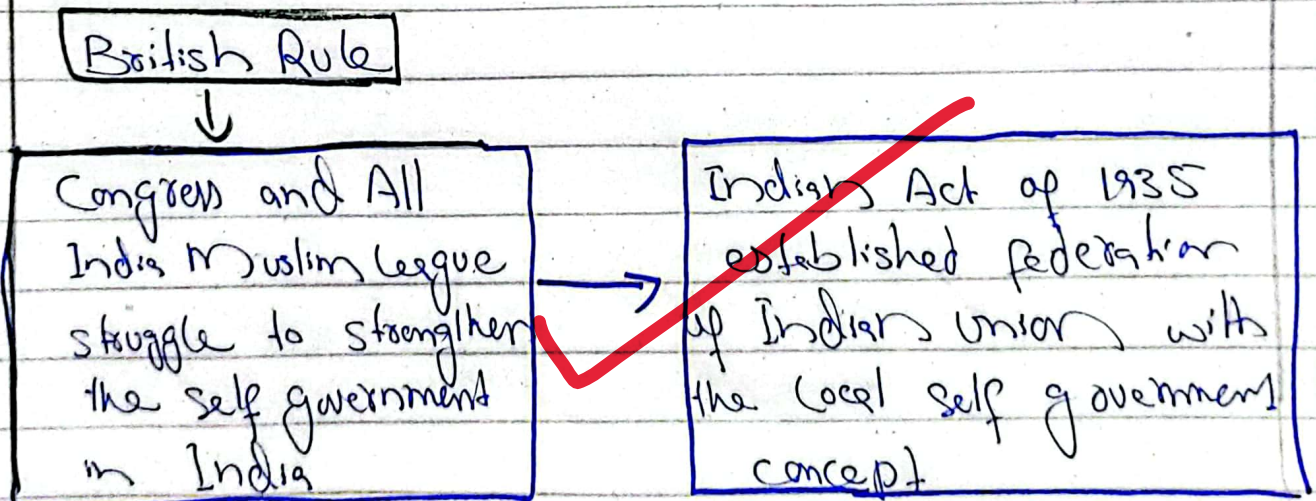


QNo: Discuss in detail the development of local self governments in Pakistan.

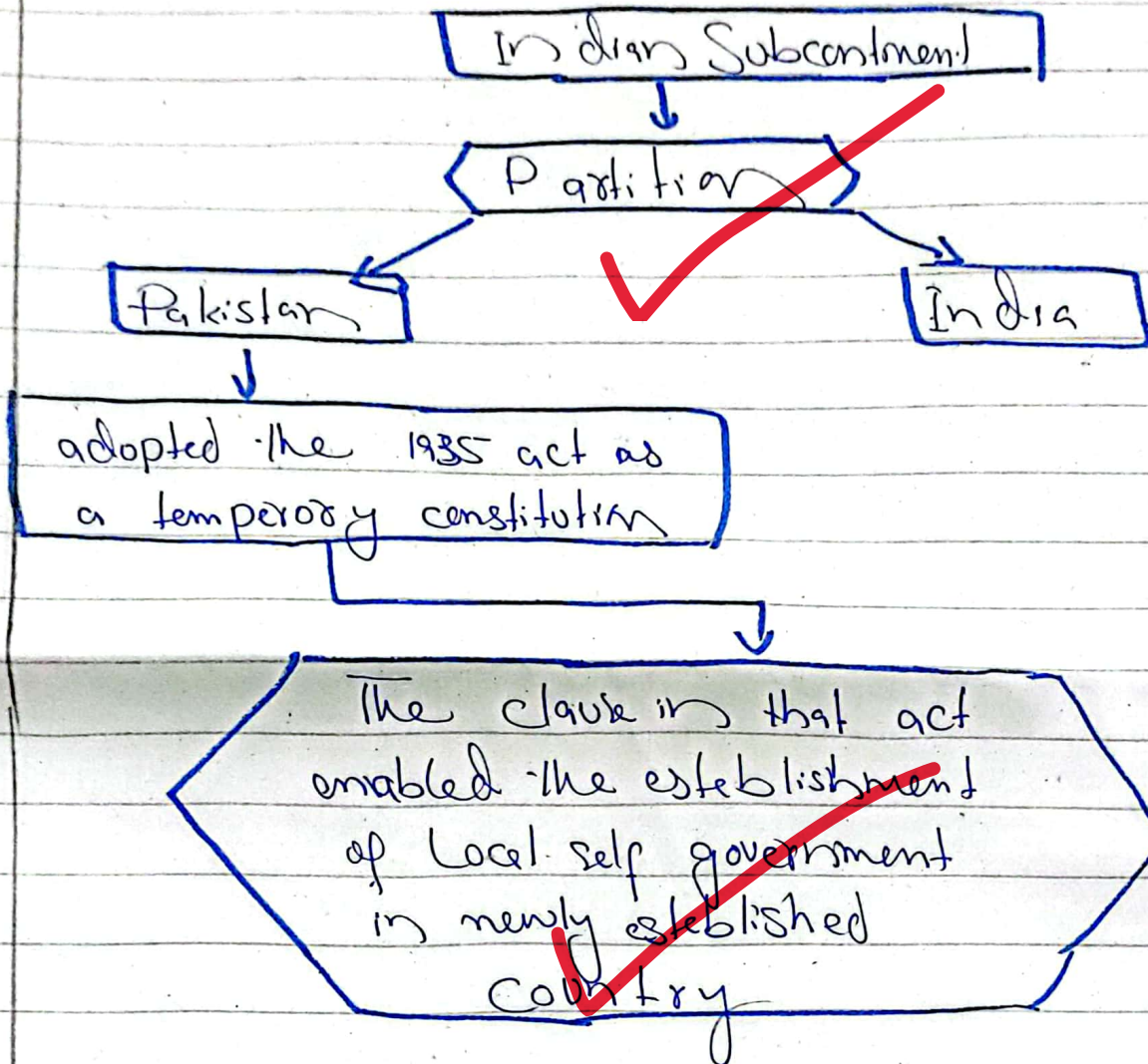
Ans: ① Introduction

③ Partition of Indian Subcontinent and 1935 act

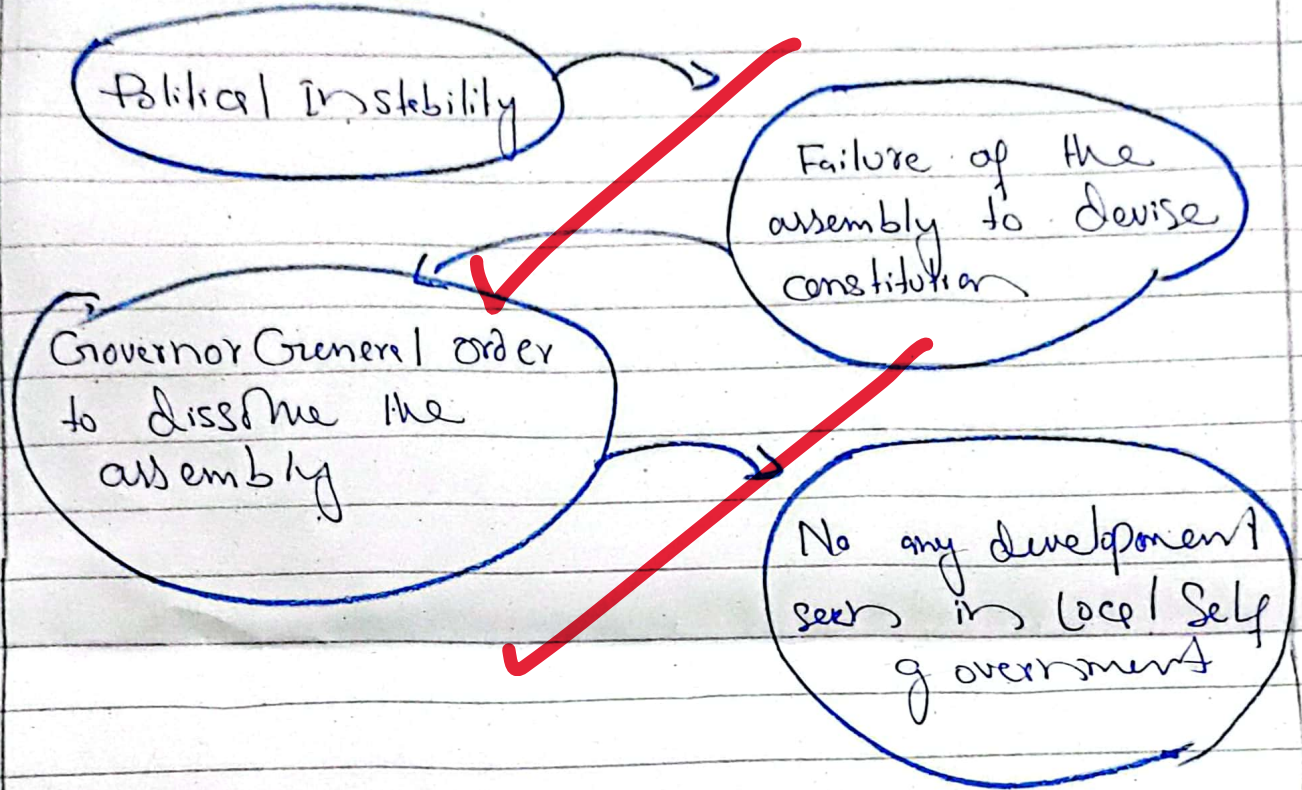


④ Initial Era of Local Self Government after the establishment as per 1935 act

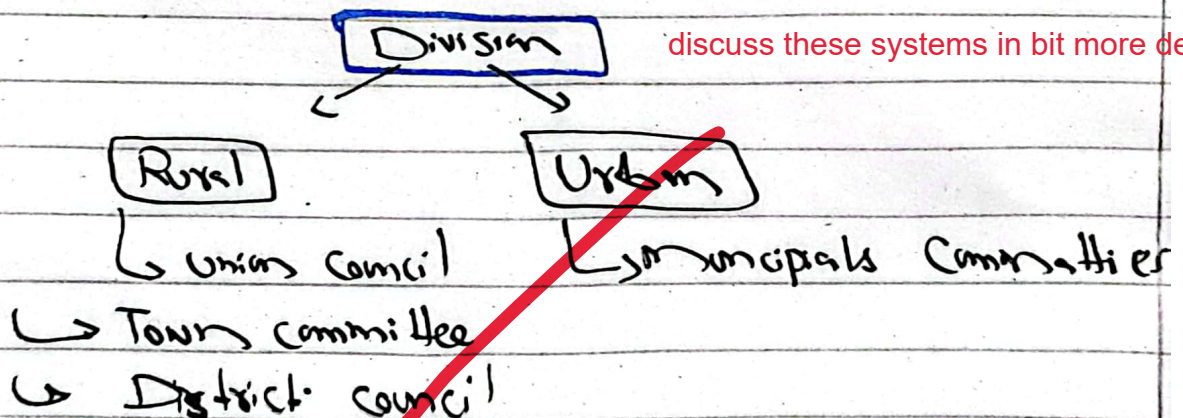

In his era he modernized the local self government. As he empower

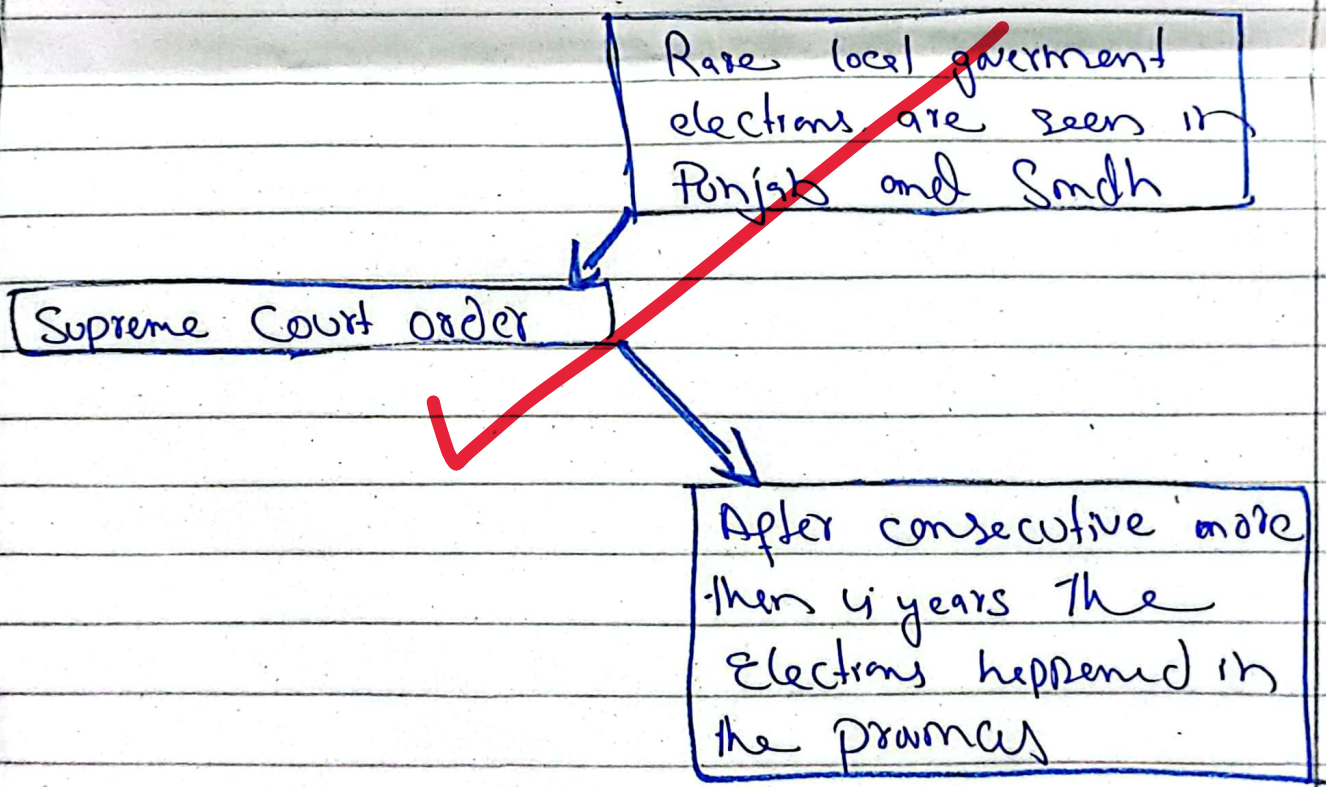
the elected leaders over the civil servants
