A family, lives in a village, Khandus near to District Matiari, Sindh, Pakistan, is belong to those poor class of people who survive on charities, such as Benezee Income Support program. The Family consist of 6 members (Father, Mother, their three sons, under age seven, and one daughter). According to them they get Benezee program support ~~times~~ in a year with maximum twenty five thousands Pakistani Rupees. The Father, who is labor in a shop and Mother, who is house cleaner, both contributed six thousand monthly to their expenses. Their children are malnourished and all parents are unable to provide them healthy food and none of the children goes to school as the poor family does not afford school expenditure. Hence, this case study is a prove that charity can not solve the issue of hunger. ~~because~~ ~~due~~ type of charity can not improve the purchasing power of the people and increasing price like justice make good out of reach for people. which resulted in to the malnutrition in poor people and weak health cause unemployment. Thus, hunger is connected to the multiple problem directly or indirectly, so government should make effective policies

which will positively affect on all causes related to hunger. Undoubtedly, Food is a basic necessity of every human being. However, world has been facing wave of hunger. which is a issue of justice but not issue of charity. Hence, effective measures are required to solve the global issue of justice.

Responsibility of world leaders - Many of the leaders trying to control the food crisis. But the problem is there an insufficient availability and when they try to generate national income from the people through tax how they can pay that because already they exist poverty in the country due to uneven distribution of income, food and so on. To generate agriculture to reduce to food crisis there is need to have availability of water, fertilizer and etc. But many of states there is unavailability of such resources. And, when states try to import food and export surplus from a country food for this need is needed but again all countries do not possess it much. Thus, whenever leaders try to solve the issue of hunger they face multiple problems and to overcome they releases support programs

which temporarily help needy people. However, Only long term policies can solve the issue of hunger and other issues related to hunger. Hence, leaders and policy makers should make an effective policies to spread justice and prosperity as charity can not solve the problem of food crisis.

Following are the key points which presents that hunger is not an issue of charity but of justice.

First of all, charity can not improve purchasing power of people. Charity is a temporary help by the state and private organizations, it can not help regularly. Most of the charities are released only once or twice in a year with minimum support. Such as Berozari Income Support Program and Ehsas Program, they comes with only minimum support, they offer (Rs. 2K-30K) two thousand to thirty thousand Pakistani Rupees, which can not fulfill yearly expenditure and purchasing power of people remain the same. Thus, the programs of charity can not change the purchasing power of people.

Secondly, these charities ~~only~~ <sup>avoid firstly or secondly</sup> release after natural disasters are affectable. As these charities can not feed affected people until they overcome with their loss. The natural disasters cause multiple problems which left people with no-home, and no-income, thus, after seeing such issue state announces programs of charities that can feed people in that situation but announced program just offer temporary relief. This temporary relief also offered in Pakistan when its people faced catastrophic flood 2022 consequences, the funds provide shelter and food to affected people but these things are not equal to the loss of the people. Hence, charities are not affectable for the people.

Thirdly, Inflation is the key factor for the increase in rate of hunger. Price hike make food out of reach for people. Almost in every states financial support are provided to needy people in any circumstances, but like in other issues like price hike, increases hunger. One of the reason of rise of inflation is Ukraine war since 2022, almost all Europe and some African countries face the consequences of the war in form of

Inflation in Russia and Ukraine are both  
are trade partners with many countries. Hence,  
Inflation also causes hunger.

Likewise, wastage of food also  
the reason to cause injustice in society.  
As this waste food is contributed ~~has~~ never  
consumed food. There are the multiple  
sources from where large amount of  
waste produced such as Restaurants,  
Marriages hall, and any other festival.  
According to INFP report, One third of  
food produced never consumed. Thus,  
the waste of food goes to dustbin and  
poor slept in his home hungry, a very  
feature of Unjustice society.

Similarly, war and displacement  
pushing people towards food  
scarcity. war and any conflict occurs  
when there is lack of social justice.  
When people do not get their rights in  
~~the~~ war like situation, they migrate,  
thus, they faced hunger issues. According to  
Universal Declaration of Human Rights, Hunger  
is a violation of rights. Thus, war like

Sequentially, Gender inequality affect food consumption. Gender inequality is one of the feature of injustice society. Female are <sup>most</sup> affected candidate of food crisis. Women face serious health issues when they do not get healthy food As compare to men, women are more mal-nutrient. Hence, Gender inequality cause hunger.

Additionally, Politics in agriculture affect food consumption promote injustice. The one who is more powerful get more food. The world is interconnected, non can survive independently. According to Dependency theory, flawed international system promote dependency, Hence, who has more power on any field, agriculture or food produce, get more benefit from it and make other it dependent. Thus, this dependency scheme of powerful promote inequality in society and keep poor hungry.

Finally, Hunger increased infant-mortality rates among poor and middle class people. Thirdly, Poor and middle

class people get malnourished. From above mentioned points it is so far clear that hunger more affected to lower class of people. And, absence of good cause shown in health. In South Asian countries where hunger rate is higher than any other region of the world, the children of this region is most malnourished as well. Hence, Despite having charity programs, hunger exist.

In addition, Hunger impedes economic growth and development. Hunger is a root cause of many other problems. These other problems as mentioned in above paragraphs are become obstacle to the economic growth and development. For suppose, in any circumstances, the rate of hunger increased, in order to overcome, officials release charity programs, but for many states it not easy to release charity programs as they are facing economic instability, however, they compromise and announce the programs. Hence, it becomes barrier to development of economic growth of the country.

Further, another aspect to injustice is that Hunger causes Unemployment. As, if people are not healthy then they are not productive. In many cases when Inflation in its peak so Labor has to face its consequences. According to some statistics, the people who worked on industries and lived in Urban areas are not as healthy as in rural areas, hence, where less productive people because of health issues contributed to unemployment rate.
