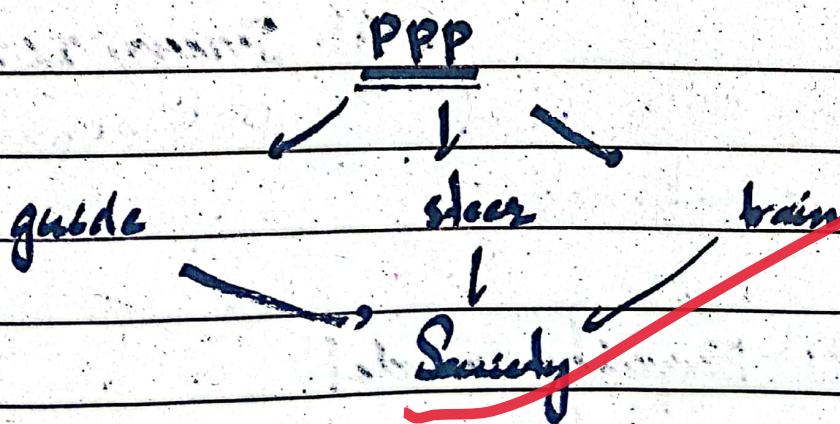

based PSD.

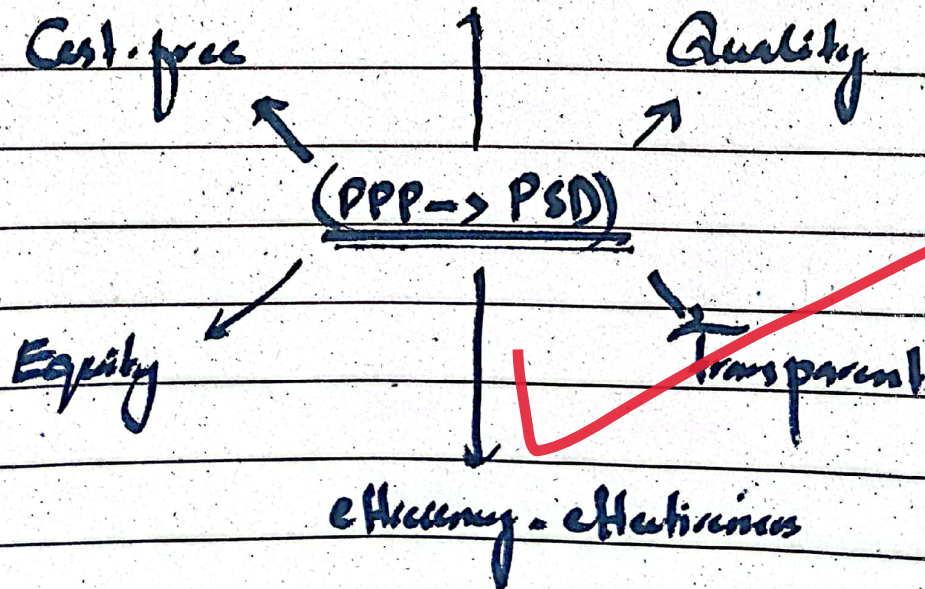
e) Cost free and quality of PSD
