Since inception, Pakistan has faced the issue of lack of political inception?. Although several efforts were made, like making of some political alliances such as Pakistan national alliance, Islami Jamhoori Ittehad (IJI), and Pakistan Democratic Movement (PDM), but mostly in vain. Till 2008, no government had successfully completed their tenure, and the country experienced martial law for more than thirty years. In 2006, charter of democracy happened, which provided some hope. However, there is still a high degree of polarization and instability in

There is death of leadership and thus it has led to poor political consensus, which has further paved way for numerous challenges.

The following paragraphs describe collective challenges which Pakistan faces

First of all, the challenges of security both at external and internal level faced by Pakistan is due to lack of political consensus. In fact, regional stability depends upon political consensus. Currently, India-Pakistan bitter relations is also because of political differences. There is a lack of negotiation between India, Pakistan, and Afghanistan. As a result, cross-border terrorism is on rise. In the same fashion, internal security situation of the country cannot improve without having proper diplomacy with non-state actors. According to the report of Transparency International, "Pakistan rank at 140th least corrupt nation out of 180 countries." (Transparency International report, 2022). This has led to the issue of bad-governance, which is a major challenge for developing countries like Pakistan.

Moreover, political instability and leadership crisis are also the challenges faced by Pakistan due to absence of political consensus. Pakistan, indeed, is multi-ethnic country and there are many political parties in different regions of the country. Punjab is mostly under control of Pakistan Muslim League (PML-N), while Pakistan Peoples Party (PPP) controls Sindh. Therefore, the difference in political vision creates instability in politics. Furthermore, there is dearth of sincere leadership, which can think for stability of the country. Politics in Pakistan is largely polarized.
