Along with ample opportunities and benefits, social media and the internet have posed serious <sup>threats</sup> challenges. The most haunting one amongst those is the threat



of cyberbullying: Cyberbullying is the use of internet and social media to harass, threaten, intimidate and harm people. First and foremost is harassment, where the perpetrator sends repetitive threatening messages, calls, and comments online with intent to distress the victim. The repetitive calls, messages and comments torture the victim and cause high level distress.

Second comes the cyber-stalking, where the perpetrator does surveillance of the recipient. It involves monitoring their social media, tracking their locations and checks, and following the victim online all the time. All

regards to his/her life, preferences about them. This helps perpetrator and victim therefore, cyberstalking is second most prominent form of cyberbullying.

Third comes outing, it is the leaking of pictures, credentials, private videos and information which is very sensitive and not supposed to be on social media or internet before public at large. All of this outing takes place without the consent of victim. The information being shared by perpetrator is to defame and embarrass them. Thus, outing is comes third in the list of forms of cyberbullying.

Last comes blackmailing, it is a very common crime committed around the globe. It is threatening by perpetrator to the victim of leaking or disclosing private information relating

to victim or some other person unless they comply with perpetrator's demand. Perpetrator threatens victim of serious consequences often of causing harm to victim in case of denial of perpetrator's demands. Thus, blackmailing is a prominent form of cyberbullying.

All of the forms of cyberbullying posit how intense is the crime of cyberbullying. Thus leading an individual to ask a question as to why all of the perpetrators commit the crime of cyberbullying, what is the motive and reason behind causing emotional, mental and sometimes physical pain to the victims. The answer to the question lies in the following.

The most prominent reason behind cyberbullying is taking revenge from victim. A Pew Research conducted in 2023 will succint to the fact. It concluded that majority of perpetrators involved in

cyberbullying were ~~are~~ doing so to take on revenge from the victim. The revenge taking is the prime reason behind the frequent happening of the crime of cyberbullying.

Secondly, cyberbullying takes place amid the power and control mentality; where a perpetrator aims at controlling the life of the victim by doing cyberbullying. A Research report by Human Rights Commission Pakistan conducted after Covid-19 posits that majority of victims were cyberbullied because the perpetrators wanted to exert their power upon them and control their life. 'Women have always been victims of power and control' said Judith Butler a prominent rights activist and scholar. Thus, power and control is the reason behind cyberbullying.

More importantly, the perpetrators find it amusing and entertaining to cyberbully someone. A survey conducted in USA from African American citizens concluded that they



were intimidated and harassed frequently after the blacks lives matter movement. (2022)

The perpetrators, when they were caught and brought to the court of law, confessed many of times that they used to do cyberbullying for entertainment purpose. Hence, it is one of the reasons behind increasingly happening online crime of cyber bullying.

Furthermore, the crime of cyberbullying happens amid the perpetrator's want of attention. It is common that some people often do not pay heed to someone in their circle or someone approaching them. This disappoints a person, thus leading him/her to cyberbully the person whose attention is required. Yuval Noah Harari in his book 21st lessons of the 21st century states that humanity is increasingly aspiring for attention seeking.
