The term 'Democracy'
appeared in the 5th century BC
in Greek city-states, notably
Classical Athens, to mean "rule
of the people", in contrast to

aristocracy, meaning "rule of an elite".
The United States is the only country
with a continuous democracy more
than 200 years old. Pakistan was
emerged with the name "Islamic
Republic of Pakistan" in 1967 but
Pakistan never became a strong
democracy due to the establishment
rule and elite capture. The democratic
elections held in 2008 were the first
to conclude a complete 5-year term
in the nation's political history. The
Charter of Democracy was signed
by Nawaz Sharif of Pakistan Muslim
League and Benazir Bhutto of Pakistan
Peoples Party on May 14, 2006 in London.
This charter is failed to complete
its objectives. Now increasing political
and economic unrest in the
country needs to focus on the
new charter of Democracy for
institutional reforms. Pakistan adopted
economic stabilization and structural
reform policies in 1988 in an effort
to reduce domestic financial imbalances
and external deficits. However, there
have been problems with the
implementation of these policies, in
terms of consistency and sequencing.

The period 1988-1996 was characterized by repeated attempts to stabilize the economy. Since policy measures were not able to achieve their objectives, economy continued to be trapped in vicious circle. Now in 2023, the situation is more worsen than the past. Pakistan needs to work on the charter of Economy.

Pakistan is entrapped in Political Unrest, there is an urgency to overcome it. During political instability nation to resist on state because of increasing extremism, terrorism and economic instability. Political polarization especially after May 9 incident following the arrest of PTI leader Imran Khan is the one such evidence. of National Document but there is no check and balance on the institutions. This situation could be handled by strong democratic state and then economic stability will only be possible.

In the strong democratic state implementation of policies will only be possible if there will be changing government; there will be policy crisis. New coming government might not follow and implement the policy made by the former government because of political polarization. Similarly when the tenure of one government is going to end it makes policies that are pro-public friendly in order to secure voter but in reality their implementation is difficult or not possible.
