

SAARC focuses on South Acion countries and its member countries share historical cultural and geographical proximity Economic reperation and Integration: Eco's initiatives aim to reduce trade barriers, enhance investment opportunities and trade facilitation. SAARC's progre in economic integration has been slower compared to ECO despite SAFTA due to bilateral disputes. Inprastructuse Development: ECO gives considerable importance to physical intrastructure development, transport networks and telecommunications. SAARC's tocus is on this aspect is relatively limited.
