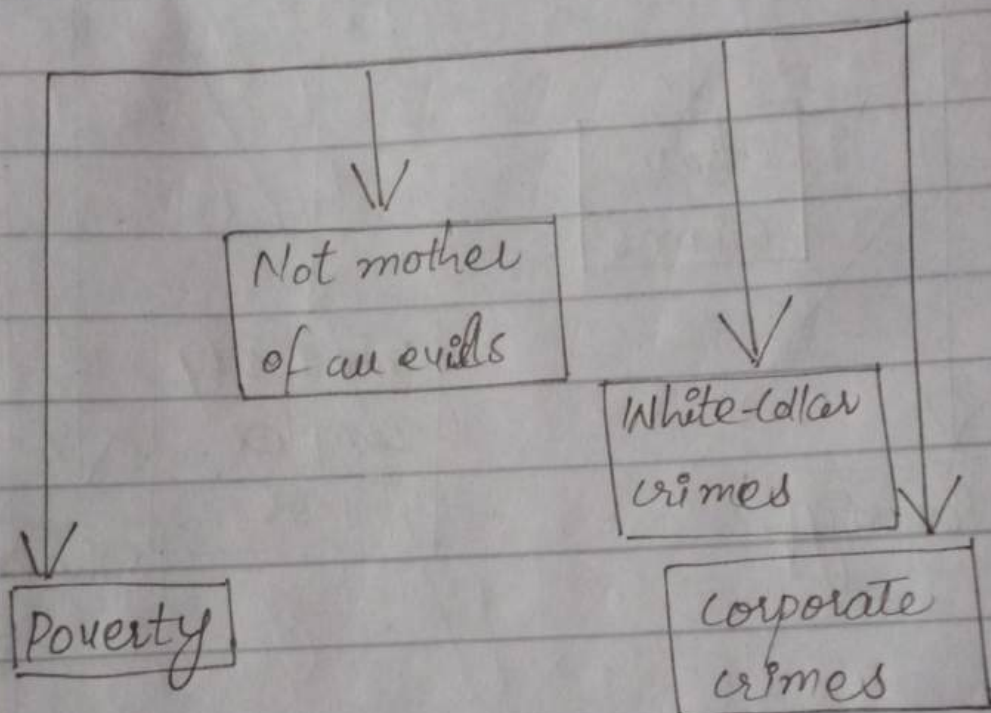


"Poverty is the mother of all evils."

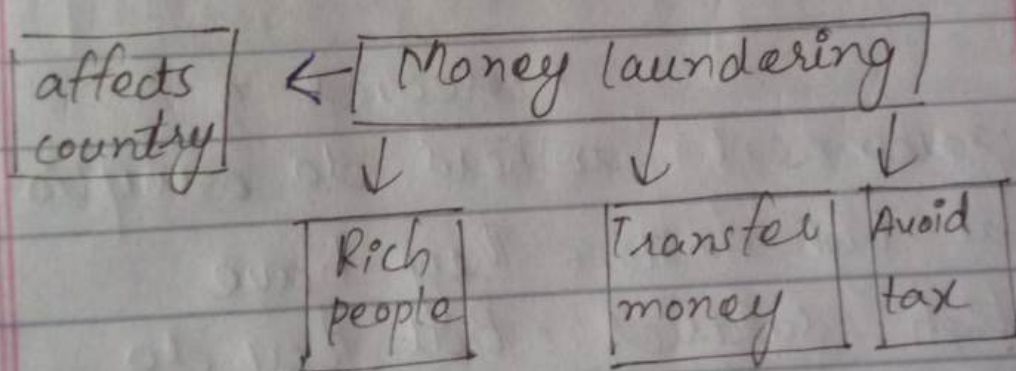
(ii) Corporate crimes by rich :

by rich people:

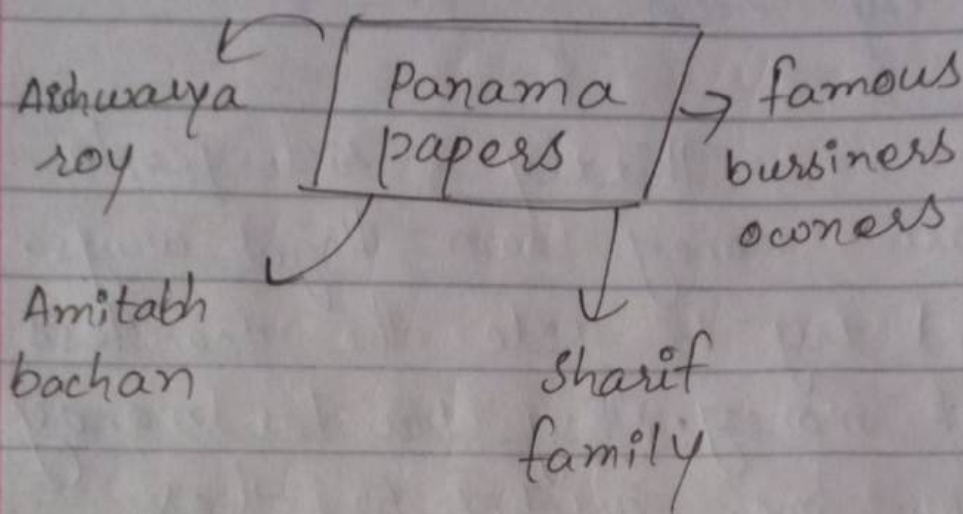
Thirdly, rich people earn money from illegal ways. And try to hide the transfers of money. They transfer money from one country to other country that is heinous crime.

“Rich parents do not have time to teach morality to children.”

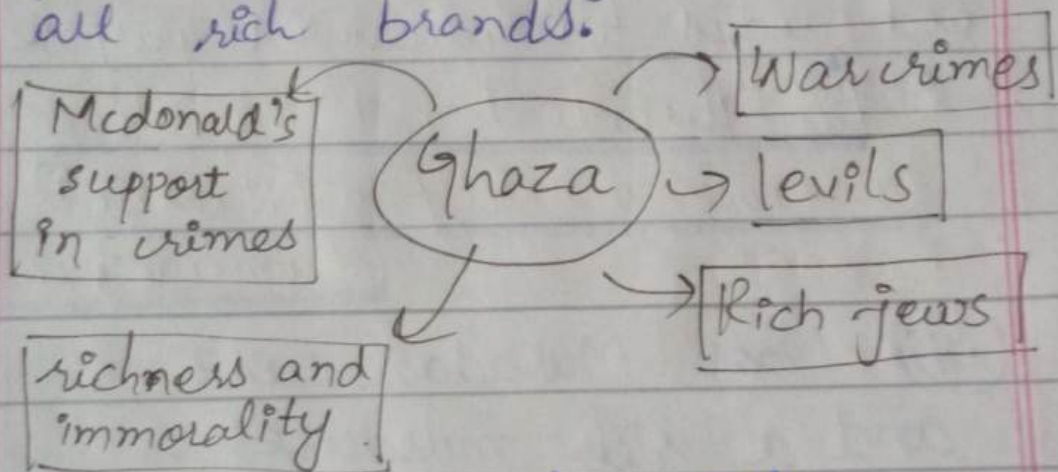

Additionally, the war crimes in Ghaza are done by rich jews. Jews are the richest people of the world. They own all rich brands.

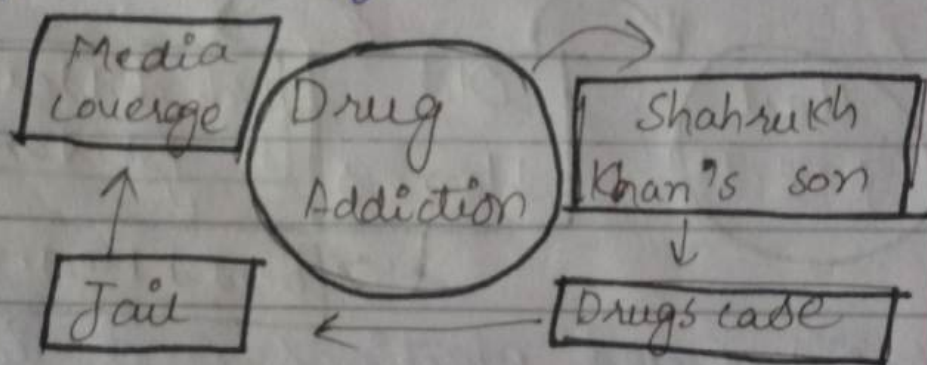


(ix) Smuggling by rich people:
