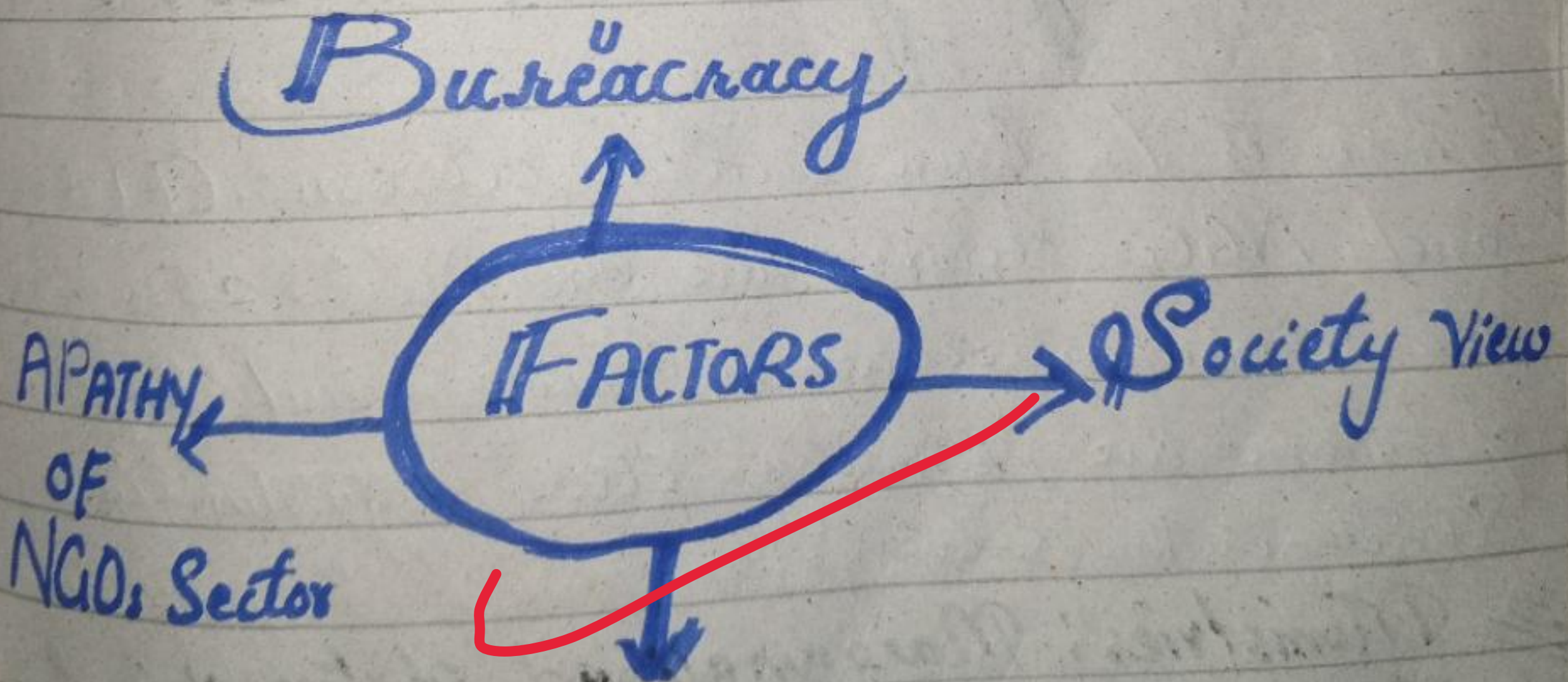
Private Public Sectors efforts to promote women studies:

Ministries: Marginalized status of Ministries of ~~NGOs~~ M-WD:

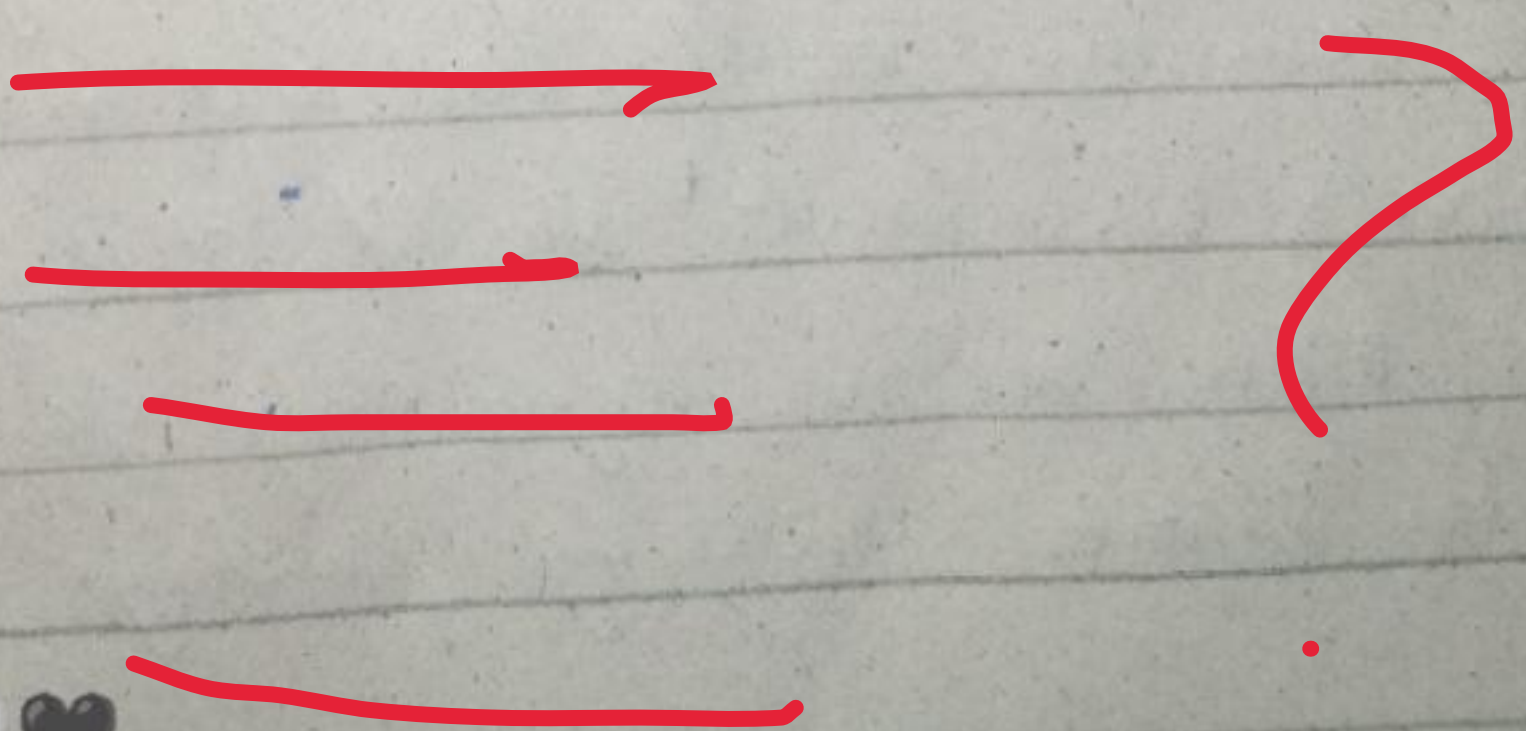
Women Studies Center had faced several
