On the other hand, human rights are being violated for a while now - from historical to contemporary violations. Political repression comes in the form of restriction of parties on the basis of any anti-state opinion. The challenges faced by ^{International} governmental organizations are lack of political will, lack of infrastructure and lack of strategic planning - for the implementation of these treaties. Furthermore, there are some way forwards through which these issues will be addressed, empower local communities, addressing root cause of violation, improve national level accountability and strengthening international mechanisms and cooperation. Even though, all human are born equal yet they are shackles everywhere due to various factors.

To begin with, debunking the fact that what human rights are. According to UDHR, human rights are rights we have simply because we exist as human beings, they are not granted by any state. These universal rights are inherent to us all, regardless of gender, race, nationality or ethnicity. They range from the most fundamental - the right to life, to those that make life worth living. Hence, human rights are most basic thing of a human's life.

Then, there are treaties to exercise all these rights, international treaties like Universal Declaration of Human Rights (UDHR), ICCPR and ICESCR, provide a legal framework for protection of human rights. These treaties outline specific rights and obligations that states must adhere to, establishing standards for human rights globally. By ratifying these treaties, states assume legal obligations to protect, respect and fulfill human rights. This includes refraining from activities that violate human rights, protecting individuals from abuses, and taking positive

steps to ensure the realization of these steps. However, the effectiveness of these treaties ~~can~~ often depends on the political will of states to implement them.

Furthermore, first historical violations of human rights were so terrible that they are even remembered till today. ~~To begin with Abolition of Slavery, for centuries millions of Africans were taken from their homes and enslaved in America and other part of the world. Abolition movement in 19th century aimed to end this brutal practice. However, the aftermath saw the emergence of systemic racism and practices like Jim Crow laws that perpetuated racial discrimination and inequality. Even though, the movement was to end this practice, yet they ended up in a more brutal phase than before.~~

Moreover, Totalitarian regime played another major role in historical violations. When Adolf Hitler or the Nazi regime systematically want to stripped Jews and disabled individuals as well as other marginalized groups of their rights, freedom of expression and individuality. All this leads to a Holocaust, that is remembered till today. During Hitler's time human rights, individual liberty, freedom of expression everything is in denial. All these totalitarian regimes lead to extreme decline of Human Rights.

In addition to, all these threats Racial segregation. This racial segregation leads to the enforcement of laws that stripped the majority. Ex of this could be the Apartheid in South Africa. The apartheid that start from 1948 to early 1990's, where Black community was not given any rights. They don't have the right to access their civil liberties like right to vote, access to quality education, freedom of expression and the freedom of movement. All these were taken away from them just because of their particular race. Thus, people have to face alot just on the basis of their race.

Likewise, cultural and religious persecution was a major violation as well. A major practice was followed in China. Between 1966 to 1976, Chinese Communist Party under Mao Zedong sought to eliminate traditional customs and traditions leading to widespread persecution of intellectuals, religious practitioners. All this leads to a one party system in China. Persecution of all intellectuals leads towards lack of freedom, lack of opinion and resulted in severe restrictions on freedom of

speech and belief. Hence, all these persecution of cultural and religious leaders resulted in a mass human inequality.

Finally, gender discrimination also played a vital role. In many parts of the world, genitals were mutilated to protect the sanctity of women. Likewise, in Afghanistan, the right of education, right to be in public spaces, right to be independent, right to do job or be in an office, everything was taken away from them in a moment. When Taliban took over the country before and in 2021 as well. These results in restriction on free speech, free movement as well as freedom of education.

Thus, all these practices were like a huge thing in terms of historical violations of human rights.

Moving forward to the contemporary aspect of human rights violations. In contemporary aspect, first we have Political Repression. In political repression, authoritarian regimes surpasses everything. Like North Korea where there is no freedom of expression, freedom of assembly. There is systematic administration discrimination, violence and a denial of human rights.

Government actions led to mass displacement and severe curtailed human rights. Thus political repression resulted in severe inefficient human rights.

Moreover, then there is censorship on digital media. Not just some countries have censored their digital media but individually meta has also censored posts or account till when supporting one particular agenda. Like, all those posts or accounts supporting Palestine in the current genocide were banned from not just meta platform but also from twitter as well. ~~On the other~~ Likewise, China has also banned/restrict social media in their country. To limit narratives regarding issues like the treatment of uighurs in xinjiang. To avoid any anti state stance they have blocked every social media platform there. Thus, all these restrictions worked as a ban on freedom of speech, freedom of expression and digital rights.

Moreover, gender based violence is like an acid on human rights, with each passing day, an increase is seen in the cases of gender based violence with an

increase in domestic abuse, acid victims, honour killings, the right to live, is in constant denial. An increased no. of cases are seen of pedophilia and necrophilia as in Pakistan, India and Bangladesh. This surge in such cases leads to the denial of freedom of speech and freedom to live.

Until now we have discussed human rights and why they are constantly declining now we'll talk about the challenges faced and what can be done to improve those challenges.

Furthermore, even after multiple treaties organizations face issues of implementation. It's hard to implement paper based treaties in real life. The main challenges faced while implementing these are lack of political will, lack of infrastructure, inadequate resources and weak enforcement mechanism. Also states may enact laws that contradict their treaty commitment or fail to provide an adequate mechanism as well as lack of individual complaint mechanism and geopolitical tensions and fragmentation. Everything all together leads to inefficiency of international organizations.
