Question no 1:- Under the unitary state system, how does the local government system work in UK?

Answer:-

* Introduction:- UK is supreme example of unitary form of government in which power of the government is vested in the center by the constitution, while local government exercises the power given by federal government. The relationship between federal and local government is of subordination. In UK, it is central government which decides the territorial boundaries functional and ~~territ~~ departmental structure of local government and decides how much financial allocation to be made for them.

* Types of the local government in ^{UK}
There are several types of local governments in UK.

1 County Councils

These are established in rural areas and are responsible for housing, education and provision of social services. For example, Kent county council in UK.

2 District Councils

These are established in smaller areas and

are responsible for housing and elderly services provisions. For example Camden council.

3 Unitary authority

In some places or areas, single unitary authority is established. Combination of the roles of county council and district council are performed by this single unit. e.g. Bristol city council.

4 Metropolitan boroughs

These local units are similar to the unitary authorities. They are established in big cities. Manchester city council is one of its example.

5 Town council

In some areas town councils are established which are responsible for managing local parks and events in their respective areas. They are usually funded by local tax called "precept".

* Relationship between Local and Federal Government

1 Delegation of Power:

Parliament is most powerful organ of UK's government. It is considered mother of all parliaments in the world.
