Secterian conflicts, ethnic issues, mis-use of Blaspherry laws, land of Islamic Education motivates the entremism on Pakistan. The menace of extremism can be handled by creating unity among muslims, providing equality to all communities, gender equality and by preaching true Islamic teachings. 2: What Is Extremism? Extremism means holding the

extreme views in politis and religion and imposing your ideology on theis Religious entremism mans holding strict beliefs of hate towards other on the basis of sectar, creed, caste, religion or nationality. 3:- Motives of Extremism In Pakistan: Pakistan is also an extremist state in case of religion. These are following motives which are triggering extremism in Pakistan; 3.1: Sectesian Conflicts: Pakistan is usually a majority Synni- seet population but Shia and Wahabi are also great in numbers. The secterian différence leads towards religious

extremism. They are moulding Islamic teaching according to their own interest and sending hate founds other. Shia-Sumi conflicts have been visen to such an extent that dozens of coeffe have been killed in Kurram Agency in November 2024. 3.2: Crender-Based Extremism: Another major reason of extremism is gender-based inequalities. In pakistan the women are not previledged just like men and are not entitled to liberty and freedom resulting in protests such as Orat March.
This enequality leads to mutiny. In Pakistan women are not entitled to equal education, Job apportunities and liberty.

According to Human Rights commission Akistan approximately 4000 women are filled annually on the name of honor. This treatment leads to extremism Use elaborate, self explanatory and referentings And Marginalised Communities Ethnically diverse region of pakistan is liable to ethnic conflicts punjoin sindhi conflicts and punjob pukktion conflicts are on op ethnic issues. Recently in November 2024 9 punjabi carrying van was bruttaly murdered by publicons in KPK. 3.4: Mis-use of Blasphony Laws. Issumic Republic of Pakistan banned un-islamic and hate fowards prophet Muhammad

and Islam by introducing article 295-c in Constitution of Pakistan. But the intelevants of pakistan are miss-using these law and using it against their own musilim brothers. There are many examples of mis-use of Blasphemy laws.

Mashal Khin marder was also the mis-use of Blaspherry laws. The murder of a Sri-lankan employee in the factory was also the case of extremism. 3.5: Lack of Education And
Mis-interpretation of Islamic Laws: is lack of education. Education empowers man with atience, dignity and intellgence leading to a peaceful society. Lack of

education results in interance and extremism. Mis-interpretation of Alamic teachings
according to own economic and
political gains are lead
towards secteramism and extremism. 4: Solutions to Get-rid of
Extremism by teachings of Islam : Here are some solutions suggestled to counter the menace of extremism according to teachings of Islam. 4.1: Unity Among Muslim Ummah: The One hundred fifty Seven million muslims of fifty seven countaires should unite for Islam despit the discrimination of seit, colo, creed and

nationality. Allah says in Quran, "Muslims are not but brothers of egy other so spread love and reducion between brothers." One reference is enough for a single Syrah- Al-Anfal says; argument Obey Allah and His menenger, and de not fall For dispute. "Hold tightly the rope of Allah and do not get disputed!" Quan Muslim ummah should unite for Islam.



4.2: Grender Equality Assurance, Gender Equality assyrance can lead to tolerance and peace and can avoid extremism. In Islam women and men are all equal. Quran says; We have executed you all from one Soul (Adam). Prophet said; All muslims are equal. No one is superior to other on the base of color, cast or cres ( Farewell Sermon). 4.3 Un-marginalised Community Marginalization of communities and discrimination leads to conflict grousal. Equal right of all

communities can avoid extremism because equally righted communities are satisfied and peaceful.
